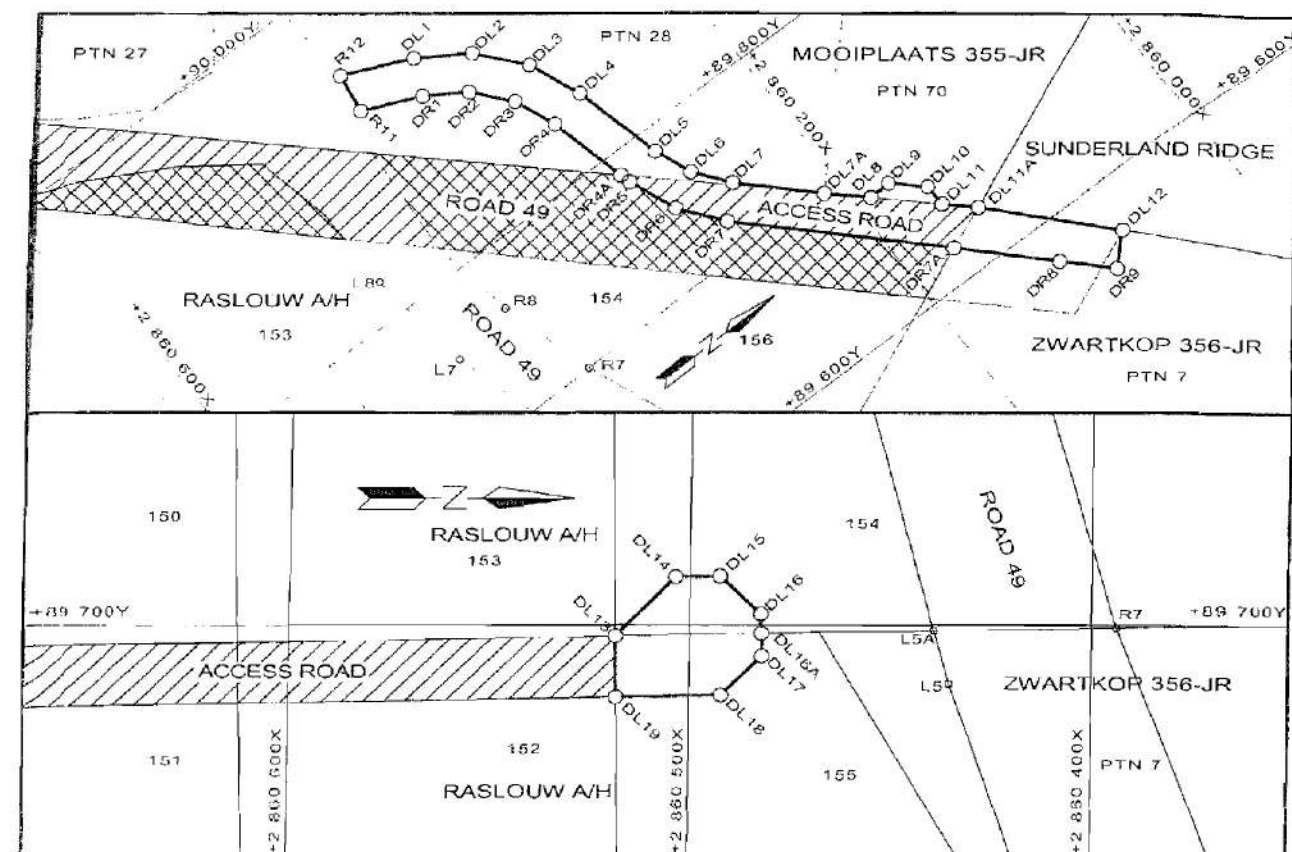

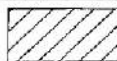

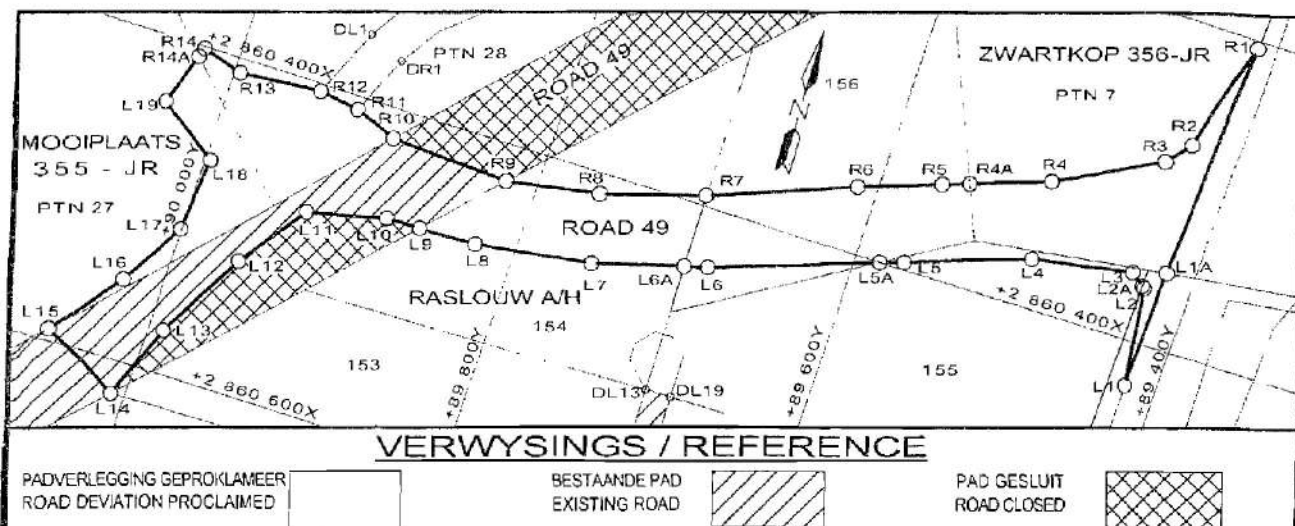
**DEVIATION OF A PORTION AND CLOSURE OF PORTIONS OF
