CALLING FOR NOMINATIONS FOR PERSONS TO SERVE AS MEMBERS ON THE GAUTENG TOWNSHIPS BOARD

The MEC for Economic Development hereby gives notice to the members of the public that the period of office of the current members of the Gauteng Townships Board will expire on the 30th of June 2012.

The Department of Economic Development accordingly invites applications/ nominations for appointment as members of the Gauteng Townships Board.

The constitutive statute of the Gauteng Townships Board is the Town-Planning and Townships Ordinance, No. 15 of 1986 ("the Ordinance"). The mandate of the Townships Board, as an appeal body, is to fast-track land development in Gauteng Province, its main function being to consider and decide upon land development applications submitted in terms of the Ordinance and prevailing legislation.

Candidates to be nominated must have a thorough knowledge and understanding of the Ordinance and laws regulating town-planning and land development. Candidates must also have knowledge and experience in at least one of the following areas:

- Development Planning • Town and Regional Planning • Law • Engineering and Infrastructure Provision
- Environmental Law and Environmental Management • Urban Design • Architecture • Economics
- Policy Information and Implementation

Please note that a person may not be a member of the Gauteng Townships Board if that person is an official employed at municipal level.

Written applications/ nominations must be supported by a Curriculum Vitae of the applicant/ nominee and an acceptance by the candidate of his/ her nomination. Selected candidates may be requested to attend an interview.
