UNAUTHORISED EXPENDITURE ACT, 2012

ACT

To provide for the authorisation of certain unauthorised expenditure from the Provincial Revenue Account; non authorisation of certain unauthorized expenditure; and to provide for matters incidental thereto.

m E}$ IT ENACTED by the Provincial Legislature of the Gauteng, as follows:—

Authorisation of certain unauthorised expenditure from the Provincial Revenue Account

1. (1) Expenditure to the amount of R780 289 034.79 incurred by the Gauteng 5 Provincial Government during the financial years 2004/05, 2005/06, 2007/08, 2008/09, 2009/10 and 2010/11; in respect of services rendered by the Gauteng Provincial Government and which the relevant Public Accounts Committees recommended for authorisation by the Legislature, is hereby authorised.

(2) The Provincial Revenue Account is charged with the expenditure contemplated in 10 Subsection (1).

(3) The expenditure referred to in Subsection (1) is set out in Schedule 1.

Non authorisation of certain unauthorized expenditure which will become the first charge against the funds allocated for the next or future financial years under the relevant vote 15

2. (1) Expenditure to the amount of R44 151 841.52 incurred by the Gauteng Provincial Government during the financial years 2003/04, 2004/05, 2005/06, 2008/09, and 2010/11; in respect of services rendered by the Gauteng Provincial Government and which the relevant Public Accounts Committees did not recommend for authorisation by the Legislature, is hereby not authorized.

(2) The relevant vote will be charged with the expenditure in Subsection (1).

(3) The expenditure referred to in Subsection (1) is set out in Schedule 2, in accordance with Section 34(2) of the Public Finance Management Act, 1999 (Act No. 1 of 1999) as amended.

Short Title

3. This Act is called the Gauteng Unauthorised Expenditure Act, 2012.
