

#### **LOCAL AUTHORITY NOTICE 300**

- 1. DETERMINATION OF A BUS RAPID TRANSIT ROUTE IN RESPECT OF THE SECOND SECTION OF THE TSHWANE RAPID TRANSIT (TRT) LINE 2A ROUTE;
- 2. DETERMINATION OF A BUS RAPID TRANSIT ROUTE AND TRT BUS TURNAROUND FACILITY IN NANA SITA STREET BETWEEN BOSMAN AND PAUL KRUGER STREET:
- 3. FIXING OF 4 (FOUR) BUS RAPID TRANSIT MEDIAN STATIONS IN RESPECT OF THE SECOND SECTION OF TRT LINE 2A IN THE MIDDLE OF THE ROAD ON KOTZE AND JORISSEN STREET PLUS 3 KERBSIDE STATIONS ON BURNETT STREET;
- 4. DETERMINATION OF A BUS RAPID TRANSIT ROUTE IN RESPECT OF THE SECOND SECTION OF THE TRT LINE 1A ROUTE; AND
- 5. FIXING OF 3 (THREE) BUS RAPID TRANSIT MEDIAN STATIONS IN RESPECT OF THE SECOND SECTION OF TRT LINE 1A IN THE MIDDLE OF THE ROAD ON PAUL KRUGER STREET AND MANSFIELD ROAD AND A TERMINAL AT WONDERBOOM STATION

Notice is hereby given, in terms of section 65bis (5) of the Local Government Ordinance 17 of 1939, that the City of Tshwane Metropolitan Municipality has:-

- approved a bus rapid transit route on the second section of the TRT Line 2A from Kotze Street (at the intersection with Nana Sita Street) along Jorissen Street until it links with Lynnwood Road. The route will follow Lynnwood Road in an eastern direction up to the intersection with University Road. Proceeding on University Road in a northern direction it links up with Burnett Street. The route proceeds on Burnett Street in an eastern direction to the intersection with Festival Street. Proceeding in a northern direction it links up with Arcadia Street where the route proceeds in an eastern direction to the intersection with Grosvenor Street. It turns into Grosvenor Street and proceeds in a southern direction to the intersection with Burnett Street. The route then proceeds in a western direction to the intersection with Festival Street and back along the same route to the point of departure;
- approved a bus rapid transit route and turnaround facility on the extension of the TRT Line 2A westbound on Nana Sita Street from the Nana Sita/Paul Kruger Street intersection for approximately 200 meters to terminate at a TRT turnaround facility between the Bosman Street and Nana Sita Street extension;
- fixed 4 (four) bus rapid transit median stations on the second part of TRT Line 2A in the middle of the road on Kotze – and Jorissen Streets, as well as 3 (three) kerbside stations on Burnett Street. Details of the stations are as follows:

- approved a bus rapid transit route on the second section of the TRT Line 1A from the
  intersection of Paul Kruger Street and Boom Street, proceeding north along Paul
  Kruger Street, turning right into Mansfield Road, proceeding north along Mansfield
  Road, until the junction with Paul Kruger Street. Here the route rejoins Paul Kruger
  Street (R101) and terminates at Wonderboom Station and return back to the CBD;
  and
- fixed 3 (three) bus rapid transit median stations on the second part of TRT Line 1A in the middle of the road on Paul Kruger Street and Mansfield Road and a terminal at Wonderboom Station. Details of the stations are as follows:
