

- 1. DETERMINATION OF A BUS RAPID TRANSIT ROUTE IN RESPECT OF THE FIRST SECTION OF THE TSHWANE RAPID TRANSIT (TRT) LINE 1A ROUTE; AND
- 2. FIXING OF 3 (THREE) BUS RAPID TRANSIT MEDIAN STATIONS IN RESPECT OF THE FIRST SECTION OF TRT LINE 1A IN THE MIDDLE OF THE ROAD ON PAUL KRUGER STREET.

Notice is hereby given, in terms of section 65*bis* (5) of the Local Government Ordinance 17 of 1939, that the City of Tshwane Metropolitan Municipality has:-

- approved a bus rapid transit route in respect of the first section of TRT Line 1A on Paul Kruger Street from the intersection of Boom Street and Paul Kruger Street in a southerly direction until it terminates at the intersection of Nana Sita Street and Paul Kruger Street and back along the same route to the point of departure; and
- fixed 3 (three) bus rapid transit median stations on the first section of TRT Line 1A in the middle of the road in Paul Kruger Street. Details of the stations are as follows:

PERMANENT CLOSURE OF PORTIONS OF PAUL KRUGER STREET BETWEEN PRETORIA STATION AND BOOM STREET FOR CERTAIN CLASSES OF TRAFFIC.

Notice is hereby given that the City of Tshwane Metropolitan Municipality has resolved to permanently close portions of Paul Kruger Street between Pretoria Station and Boom Street for certain classes of traffic to facilitate the implementation of its Tshwane Rapid Transit (TRT) System. # Zone 1 - South of Nana Sita (Skinner) Street between Nana Sita Street and Pretoria Station

To be closed for all classes of vehicle traffic, except:

- Property owners, employees and visitors, as well as delivery services:
- · Cyclists; and
- Emergency vehicles to access Paul Kruger.
- Pedestrians

## Zone 3 – Church Square (Pretorius Street to Madiba Street)

To be closed for all classes of vehicle traffic, except:

- City of Tshwane Rapid Transit (TRT) buses
- Cyclists; and
- Pedestrians

#### <u>Zone 2 – Nana Sita (Skinner) Street to</u> Pretorius Street.

To be closed for all classes of vehicle traffic, except:

- Property owners, employees and visitors, as well as delivery services:
- · Cyclists; and
- Emergency vehicles to access Paul Kruger.
- City of Tshwane Rapid Transit (TRT) buses
- Pedestrians

#### Zone 4 – Madiba Street to Boom Street

To be closed for all classes of vehicle traffic, except:

- Property owners, employees and visitors, as well as delivery services:
- Cyclists; and
- Emergency vehicles to access Paul Kruger.
- City of Tshwane Rapid Transit (TRT) buses
- Pedestrians

The above closures of portions of Paul Kruger Street to certain classes of traffic will come into effect on the date of promulgation of this Notice in the Provincial Gazette.
