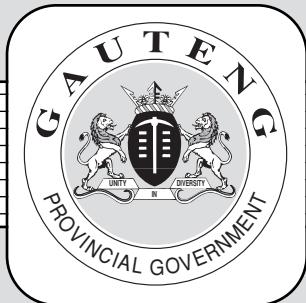



### LOCAL AUTHORITY NOTICE 601

#### CORRECTION NOTICE

The City of Johannesburg Metropolitan Municipality herewith gives notice in terms of the provisions of Section 80 of the Town Planning and Townships Ordinance, 1986, that Local Authority Notice 180 dated 12 February 2014, in respect of **Boundary Park Extension 31**, has been amended, as follows:

#### A. THE ENGLISH NOTICE:

By the insertion of the following after clause 3(1)(c) :

"(2) ERVEN 136 AND 137

The erven shall not be alienated or transferred without the written consent of the local authority first having been obtained and the local authority shall have an absolute discretion to withhold such consent, unless the transferees accept the following condition: The local authority had limited the electricity supply to the erven to 210kVA/300Amps and should the registered owners of any of the erven exceed the supply or should an application to exceed such supply be submitted to the local authority, additional electrical contributions as determined by the local authority, shall become due and payable to the local authority by such owner/s."
