

NOTICE OF INTENTION TO PROMULGATE REGULATIONS UNDER THE NATIONAL LAND TRANSPORT ACT, 2009 (ACT NO.5 OF 2009)

l<sub>2</sub>Dr Ismail Vadi, Member of the Executive Council of the Gauteng Provincial Government responsible for Roads and Transport hereby, acting under section 91(3) of the National Land Transport Act, 2009, (Act no. 5 of 2009) publish my intentions to implement regulations in terms of section 91(2) declaring area/s as per the attached schedule, where extraordinary measures are to apply. These area/s are characterized by violence, unrest or instability and the measures are intended to normalize the situation.

The affected routes and taxi ranks are to be closed for the operation of public road passenger services until further notice. During this period, no person shall be allowed to undertake passenger road transport service in that affected route.

The Regulations I intend to implement will be in force and effect from 00H01 on the 17<sup>th</sup> day of December 2014 to 00H00 on the 17<sup>th</sup> day of January 2015.
