PROCLAMATION • PROKLAMASIE**PROCLAMATION 153 OF 2016****THE PREMIER****GAUTENG PROVINCE****GAUTENG LAND ADMINISTRATION ACT, 1996****(Act No. 11 of 1996)****TRANSFER OF ADMINISTRATION OF POWERS AND FUNCTIONS ENTRUSTED
BY LEGISLATION FROM ONE TO ANOTHER MEMBER OF THE EXECUTIVE
COUNCIL IN TERMS OF SECTION 137 OF THE CONSTITUTION OF THE
REPUBLIC OF SOUTH AFRICA, 1996**

In terms of section 137 of the Constitution of the Republic of South Africa, 1996, I hereby transfer the administration of the powers and functions conferred by—

- (a) sections 2, 2A, 3, 4, 6(10) and 7 of the Gauteng Land Administration Act, 1996 (Act No. 11 of 1996) ("the Act"), and which were previously assigned to the Member of the Executive Council ("MEC") responsible for Development Planning and Local Government in the Province, except in relation to roads and intermodal facilities, to the MEC responsible for Infrastructure Development in the Province; and
- (b) the above stated sections, in so far as roads and intermodal facilities are concerned, to the MEC responsible for Roads and Transport in the Province.



Notice No. 22 of 1998 promulgated in Provincial Gazette No. 506 of 1998 dated 30 June 1998 and Notice No. 3122 of 2000 promulgated in Provincial Gazette No. 56 of 2000 dated 19 May 2000 are hereby withdrawn.





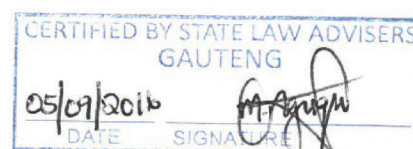
