Notice is hereby given, in terms of 21 and 41 of the city of Johannesburg Municipal Planning By-Law, 2016 that we, G N & A Georgoulakis, being the owners intend to apply to the City of Johannesburg for the amendment of the Sandton Town Planning Scheme 1980 and removal of restrictive conditions of title.

**Site Description:** Erf 1691 Bryanston situated at 11 Charles Street, Bryanston.
