<b>Purpose</b>	<ul style="list-style-type: none"> <li>The purpose of this grant is to provide financial assistance to the Merafong Local Municipality towards the replacement of water services infrastructure for water supply purposes in Khutsong Ext. 1,2,4 and Welverdiend.</li> </ul>
<b>Measurable outputs</b>	<ul style="list-style-type: none"> <li>Khutsong Extension 1,2,4 including Welverdiend boasts a total of 8 207 Erven with an estimated population of 23 802 residents.</li> <li>Water and sanitation services are adversely affected due to the pipeline being damaged. The entire project will entail the delivery of the following:               <ol style="list-style-type: none"> <li>Curtain Grouting around the sinkhole,</li> <li>Replacement of pipe line including the Construction of support concrete plinths.</li> </ol> </li> </ul>
<b>Conditions of the grant:</b>	<p>The funding will only be utilized to cover the costs for improvement of the geotechnical conditions and the replacement of the pipe line.</p> <ul style="list-style-type: none"> <li>Project cost estimate has been determined;</li> <li>A report for on the expenditure incurred has been submitted;</li> <li>A joint project management committee to fulfil the monitoring, evaluation and reporting on the project was established between COGTA.</li> </ul>
<b>Allocation Criteria:</b>	<ul style="list-style-type: none"> <li>The allocation is based on the request made by the municipality for the replacement of water services damaged by sinkhole occurrence in the Municipality affecting the Khutsong Extension 1,2 &amp; 4 and Welverdiend communities.</li> <li>Allocation is based on costs presented by the Municipality for the work already undertaken.</li> </ul>

<b>Reasons not included in the equitable share:</b>	<ul style="list-style-type: none"> <li>According to section 154 (1) of the Constitution, the national and provincial governments by legislative and other measures, must support and strengthen the capacity of municipalities to manage their own affairs to exercise their powers and their functions</li> </ul> <p>The occurrence of sinkholes due to dolomitic conditions is simply unpredictable and thus a municipality cannot plan for them. Hence the municipality made the request for funding to commence with the project. Without this financial support,</p>



	the communities affected will continue to have inadequate water supply at all.
