EKURHULENI TOWN PLANNING SCHEME, 2014  
CITY OF EKURHULENI AMENDMENT SCHEME B0142**

It is hereby notified in terms of Section 57(1)(a) of the Town Planning and Townships Ordinance, 1986 (Ordinance 15 of 1986), read together with the Spatial Planning and Land Use Management Act, 2013 (Act No.16 of 2013) that the City of Ekurhuleni Metropolitan Municipality has approved the amendment of the Ekurhuleni Town Planning Scheme, 2014 by the rezoning of :

1. Erf 132, Norton Park X 7 Township from "Special" for 'Guard House' to "Special" for 'Residential 2' (subject to conditions); and
2. Portion of Erf 158, Norton Park X 7 Township from "Special" for 'Refuse Collection' to "Special" for 'Residential 2' (subject to conditions); and
3. Erf 163, Norton Park X 7 Township from "Special" for 'Recreation Centre' to "Special" for 'Residential 2' (subject to conditions).

The amendment scheme documents will lie for inspection during normal office hours at the offices of Head of Department: City Planning, City of Ekurhuleni Metropolitan Municipality, and at the offices of the Area Manager: City Planning Department, Benoni Civic Centre; as well as at the Gauteng Provincial Government, Office of the Premier, Gauteng Planning Division.

This amendment scheme was previously known as Benoni Amendment Scheme 1/1749 and is now known as Ekurhuleni Amendment Scheme B0142. This Scheme shall come into operation from date of publication of this notice.
