### LOCAL AUTHORITY NOTICE 886 OF 2018

#### CITY OF EKURHULENI METROPOLITAN MUNICIPALITY DECLARATION AS APPROVED TOWNSHIP

IN TERMS OF SECTION 103 OF THE TOWN PLANNING AND TOWNSHIPS ORDINANCE, 15 OF 1986, THE EKURHULENI METROPOLITAN MUNICIPALITY HEREBY DECLARES JANSEN PARK EXTENSION 29 TOWNSHIP TO BE AN APPROVED TOWNSHIP SUBJECT TO THE CONDITIONS SET OUT IN THE SCHEDULE HERETO.

#### SCHEDULE

**STATEMENT OF THE CONDITIONS UNDER WHICH THE APPLICATION MADE BY CHRIMARK PROPERTIES (PROPRIETARY) LIMITED No. 1998/017840/07 (HEREINAFTER REFERRED TO AS THE APPLICANT/TOWNSHIP OWNER) UNDER THE PROVISIONS OF PARTS A AND C OF CHAPTER 3 OF THE TOWN PLANNING AND TOWNSHIPS ORDINANCE, 1986 (ORDINANCE 15 OF 1986), FOR PERMISSION TO ESTABLISH A TOWNSHIP ON PORTION 1042 OF THE FARM KLIPFONTEIN 83 IR HAS BEEN GRANTED**

#### 1. CONDITIONS OF ESTABLISHMENT

1.1 **NAME**

The name of the township shall be Jansen Park Extension 29.

1.2 **DESIGN**

The township shall consist of erven and streets as indicated on General Plan S.G. No. 2938/2010.

1.3 **DISPOSAL OF EXISTING CONDITIONS OF TITLE**

All erven shall be made subject to existing conditions and servitude's, if any, including the reservation of rights to minerals.

1.4 **ENDOWMENT**

The township owner shall, in terms of section 98(2) and (3) of the Town- planning and Townships Ordinance, 1986 pay a lump sum endowment to the Local Authority which amount shall be used by the Local Authority for the provision and maintenance of parks in or for the township.

Such endowment, is payable in terms of the provisions of section 81 of the said ordinance read with section 95 thereof prior to the issuing of the Section 82 certificate.

The abovementioned endowment can be offset by the provision of suitable open space via the submission of an SDP to the Area Manager: City Planning for each erf, showing the dedicated required open space as such.

1.5 **DEMOLITION OF BUILDINGS AND STRUCTURES**

The township owners shall at their own expense cause all existing buildings and structures situated within the building line reserves, side spaces or over common boundaries to be demolished to the satisfaction of the local authority, within a period of six (6) months from the date of publication of this notice.

1.6 **REMOVAL OR REPLACEMENT OF MUNICIPAL SERVICES**

If, by reason of the establishment of the township, it becomes necessary to remove or replace any existing municipal services, the cost thereof shall be borne by the township owners.

1.7 **ACCESS**

Ingress to and egress from the township shall be from Sydney Road to the satisfaction of the Roads, Transport and Civil Works Department.

1.8 **CONSOLIDATION OF ERVEN**

The township owner shall at his own expense cause Erven 366 and 367 in the township to be consolidated within six months from declaration of the township as an approved township.

#### 2. CONDITIONS OF TITLE

2.1 All erven shall be subject to the following conditions, imposed by the local authority in terms of the provisions of the Town Planning and Townships Ordinance, 1986.

- (1) The erf is subject to a servitude, 2m wide, in favour of the local authority, for sewerage and other municipal purposes, along any two boundaries other than a street boundary and in the case of a panhandle erf, an additional servitude for municipal purposes 2m wide across the access portion of the erf, if and when required by the local authority: Provided that the local authority may dispense with any such servitude.

- (2) No building or other structure shall be erected within the aforesaid servitude area and no large-rooted trees shall be planted within the area of such servitude or within 2m thereof.
  - (3) The local authority shall be entitled to deposit temporarily on the land adjoining the aforesaid servitude such material as may be excavated by it during the course of the construction, maintenance or removal of such sewerage mains and other works as it, in its discretion may deem necessary and shall further be entitled to reasonable access to the said land for the aforesaid purpose subject to any damage done during the process of the construction, maintenance or removal of such sewerage mains and other works being made good by the local authority.
