NOTICE 454 OF 2019**GAUTENG DEPARTMENT OF ROADS AND TRANSPORT****NATIONAL LAND TRANSPORT ACT, 2009 (ACT NO. 5 OF 2009)****APPLICATION OF EXTRAORDINARY MEASURES IN THE AREA OF JURISDICTION OF THE JOHANNESBURG METROPOLITAN MUNICIPALITY (ROUTES AND RANKING FACILITIES OPERATED BY WITWATERSRAND AFRICAN TAXI OWNERS ASSOCIATION AND NANCEFIELD DUBE WEST TAXI ASSOCIATION)**


WHEREAS, Section 91 of the National Land Act, 2009 (Act No.5 of 2009) vests the executive powers in the Member of the Executive Council responsible for public transport; and

WHEREAS, under Section 91 of the National Land Transport Act, 2009 (Act No.5 of 2009), a Member of the Executive Council may in a defined area/s declare it to be an area/s characterised by violence, unrest or instability in which extraordinary measures may be prescribed; and

WHEREAS, under Notice 415 of 2019 published under Provincial Gazette No. 73 of 06 March 2019, I have expressed my intention to promulgate regulations declaring the routes and ranks operated by Witwatersrand African Taxi Owners Association (WATA) and Nancefield Dube West Taxi Association (NANDUWE) to be areas of violence, unrest or instability; and

NOW THEREFORE, I, Dr Ismail Vadi, **Member of the Executive Council for the Gauteng Provincial Government** responsible for Roads and Transport, being of the opinion that it is necessary to normalize the situation in the area/s characterized by violence, unrest or instability in the minibus taxi industry, and that it is in the interest of passengers using the relevant service, residents or any other persons entering the area/s, hereby declare the routes and ranks identified in the Schedule within the jurisdiction of the Johannesburg Metropolitan Municipality (operated by the Witwatersrand African Taxi Owners Association and the Nancefield Dube West Taxi Association) in terms of Section 91(2) of the National Land Transport Act (Act No.5 of 2009), to be area/s where the extraordinary measures provided for in Section 91(1) are applicable.

I hereby make the regulations in the Schedule in terms of Section 91(3) read with other sections of the National Land Transport Act, 2009 (Act No.5 of 2009).

SCHEDULE**Areas for extraordinary measures**

1. The following routes and ranks shall remain closed for minibus taxi type service commencing at 00h01 on 15 March 2019 until 15 June 2019 at 00h01-

Mofolo Sizwe Stores Taxi Rank	John Page Drive and Main Street, Jeppe Station Taxi Rank	From Mphuthi Street (c/o Mphuthi Street and Banda St), continue Machaba Drive, continue Mwasi Street, Turn right Mzilikatse Street, Turn left Mncube drive, Turn right Mtipa Street, continue Sobuza Street, Turn Right Butshingi Street, Turn left Mtipa Street, Turn right Kumalo main road, continue Sofasonke Street, Turn left Mooki Street, Turn right Soweto Highway, continue Pat Mbatha Bus and Taxi Way, continue Pat Mbatha Bus Way, continue Busway, continue Bezuidenhout Street, Turn right Market Street, continue Interchange, continue Commissioner Street, Turn right John Page Drive, end (c/o John Page Drive and Main St)
Kwa Mthetwa Stores (Machaba and Nxumalo Streets) - Mofolo	John Page Drive and Main Street, Jeppe Station Taxi Rank	From Mthetwa Stores (corner of Machaba Drive and Nxumalo Street) turn left into Nxumalo Street, proceed to Dube Station Rank and turn right into Ncube Drive, turn left into Mahalefela Road, proceed to Pela main Road, then Pela becomes Khumalo Street proceed over Klip Valley Road to Sofasonke Street

Dube Station Rank	John Page Drive and Main Street, Jeppe Station Taxi Rank Street	From Dube Station Taxi Rank (Leselinyane Street and Ncube Drive) proceed to Mahalefela Road, turn left into Mahalefela Road, proceed to Pela Main Road, then it becomes Khumalo Street, proceed over Klip Valley Road to Sofasonke Street
Makhetha Garage (Pela and Mahalefela Road)	John Page Drive and Main Street, Jeppe Station Taxi Rank	From Makhetha Garage (Pela Main Road) proceed to Khumalo Road and proceed over Klip Valley Road to Sofasonke Street
Uncle Tom's Hall (Orlando West)	John Page Drive and Main Street, Jeppe Station Taxi Rank	From Uncle Tom's Hall in Khumalo Street proceed over Klip Valley Road to Sofasonke Street.

Offences and penalties

2. A person is guilty of an offence if that person operates minibus taxi services in contravention of regulation 1.
3. Where a person is convicted of contravening regulation 1, a term of imprisonment not exceeding six months or a fine not exceeding R25 000.00 may be imposed.

Short title and commencement

4. These regulations are called Gauteng Public Transport Extraordinary Measures, 2019, and come into operation at 00h01 on 15 March 2019.
