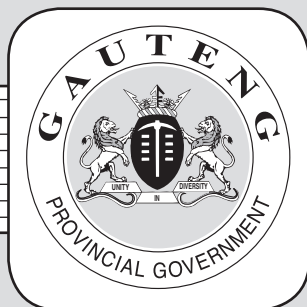

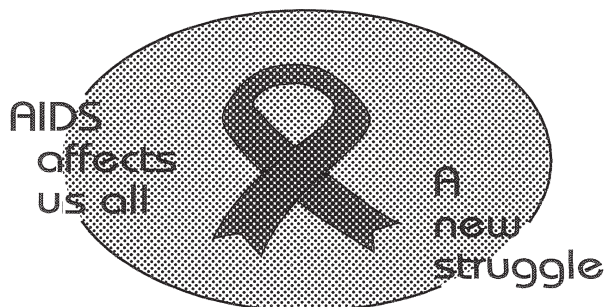

MANAGEMENT: PROTECTED AREAS ACT, NR. 57 of 2003****INTENTION TO DECLARE NATURE RESERVES AND A PROTECTED ENVIRONMENT**

I, Lebogang Maile, the Member of the Executive Council (MEC) responsible for Economic Development, Environment, Agriculture and Rural Development in the Gauteng Province, in terms of section 33(1) of the National Environmental Management: Protected Areas Act, 2003 (No 57 of 2003), do hereby publish:

- (1) the intention to declare the Crocodile River Reserve Doornrandje Nature Reserve Cluster and the Crocodile River Reserve Central Nature Reserve Cluster under section 23 of the National Environmental Management: Protected Areas, Act nr. 57 of 2003, as amended ("the Act"); and
- (2) the intention to declare the Crocodile River Reserve Protected Environment under section 28 of the Act.

The proposed nature reserve clusters and the proposed protected environment are located on the properties as indicated in Schedules 1, 2 and 3 below.

Members of the public are hereby invited to submit written representations on or objections to the notice on the proposed declarations of the above-mentioned Nature Reserve Clusters and the Protected Environment, within 60 days of its publication in the Provincial Gazette.
