The Speaker of Council, Cllr RK Mathebe, in accordance with sections 160(4) and (6) of the Constitution of the Republic of South Africa, 1996, read with sections 11 to 13 of the Local Government: Municipal Systems Act, 2000 (Act 32 of 2000) and section 7 of the Rationalisation of Local Government Affairs Act, 1998 (Act 10 of 1998), pursuant to the Council resolution adopted on 28 February 2019, hereby invites the public and relevant stakeholders to submit comments on the draft revised City of Tshwane: Rules and Orders By-law (2012) before final approval by Council.

The purpose of revising the City of Tshwane: Rules and Orders By-law, which, in accordance with section 160(6) of by the Constitution of the Republic of South Africa, 1996, prescribes rules and orders for the municipal council's internal arrangements, is aimed at providing the City of Tshwane with legislative measures to conduct orderly meetings of its Council and committees, and the revised by-law will replace the current Rules and Orders By-law (2012).
