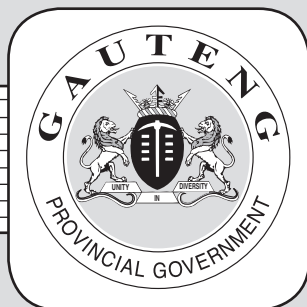

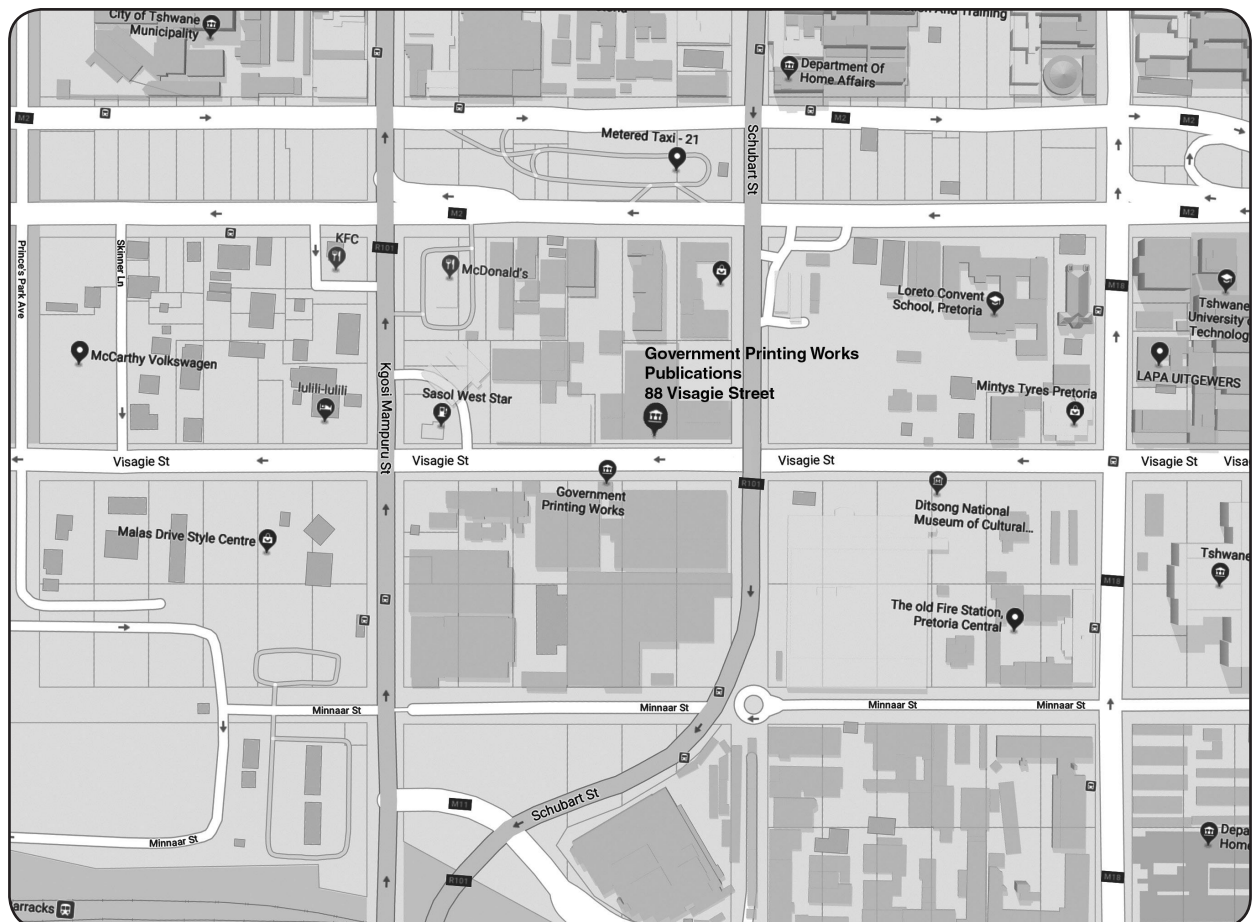

CORRECTION NOTICE: BARTLETT EXTENSION 89 TOWNSHIP

Notice is hereby given in terms of Section 80 of the Town Planning and Townships Ordinance, 15 of 1986, read with Section 95 of the said ordinance that an error occurred in the Conditions of Establishment in respect of Bartlett Extension 89 Township established under Local Authority Notice 252 dated 20 February 2019 and is hereby corrected as follows:

1. By the amendment of condition 1.9. to read as follows:

1.9. SERVITUDES

(a) A servitude, 6m x 8m must be registered over Erf 1033 in favour of the local authority for a municipal sub-station.

(b) A right of way servitude for engineering services in favour of all residence as well as the erven in the township of Bartlett Extension 93 and the local authority.

2. By the inclusion of the following condition:

1.10. NOTARIAL TIE OF ERVEN

The township owner shall at his own expense cause the erven within the Bartlett Extensions 89 and 93 and Erf 1222 Impala Park to be notarial tied to each other, within six months from declaration of the respective townships as approved townships for access purposes.

CORRECTION NOTICE: BARTLETT EXTENSION 93 TOWNSHIP

Notice is hereby given in terms of Section 80 of the Town Planning and Townships Ordinance, 15 of 1986, read with Section 95 of the said ordinance that an error occurred in the Conditions of Establishment in respect of Bartlett Extension 93 Township established under Local Authority Notice 253 dated 20 February 2019 and is hereby corrected as follows:

1. By the amendment of the first paragraph to read as follows:

In terms of Section 103 of the Town Planning and Townships Ordinance, 15 of 1986, the City of Ekurhuleni Metropolitan Municipality hereby declares Bartlett Extension 93 Township to be an approved township subject to the conditions set out in the schedule hereto.

2. By the amendment of condition 1.8. to read as follows:

Ingress and egress to and from the township shall be via Erf 1222 Impala Park to the satisfaction of the Roads and Stormwater Department. No access will be permitted from Ridge Road.

3. By the inclusion of the following condition:

1.10. NOTARIAL TIE OF ERVEN
