

EKURHULENI TOWN PLANNING SCHEME, 2014
EKURHULENI AMENDMENT SCHEME B0331**

It is hereby notified in terms of section 57(1)(a) of the Town Planning and Townships Ordinance, 1986 (Ordinance 15 of 1986), read together with SPLUMA, that the City of Ekurhuleni Metropolitan Municipality has approved the amendment of the Benoni Town Planning Scheme, 1947 by the simultaneous rezoning and subdivision of Portion 5 of Erf 1933 Rynfield Township and the simultaneous subdivision of same from "Public Open Space" to "Special" for Residential 2 in respect of the proposed Portion 6 of Erf 1933 Rynfield, "Special" for Residential 3 in respect of the proposed Portion 8 of the Erf 1933 Rynfield and Private Open Space in respect of the proposed Portion 7 of Erf 1933 Rynfield, subject to conditions.

The amendment scheme documents will lie for inspection during normal office hours at the offices of the Head of Department: City Planning, City of Ekurhuleni Metropolitan Municipality, and at the offices of the Area Manager: City Planning Department, Benoni Civic Area; as well as at the Gauteng Provincial Government, Office of the Premier, Gauteng Planning Division.

This amendment scheme was previously known as Benoni Amendment Scheme 1/2054 and is now known as Ekurhuleni Amendment Scheme B0331. This Scheme shall come into operation from date of publication of this notice.
