

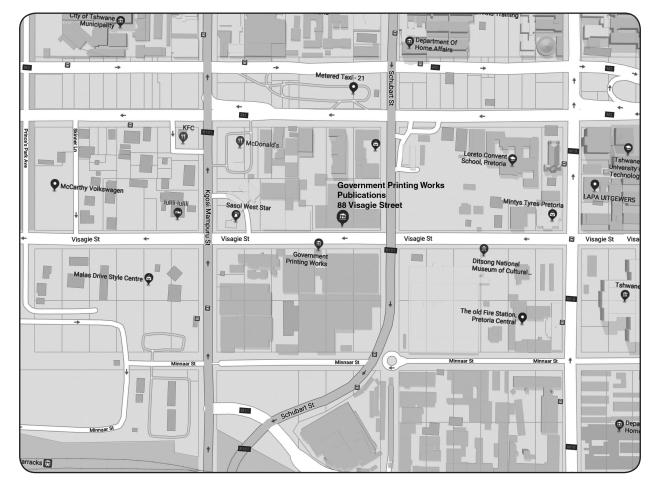

DETERMINATION OF NUMBER OF COUNCILLORS IN TERMS OF SECTION 18(3) OF THE LOCAL GOVERNMENT: MUNICIPAL STRUCTURES ACT, 1998

Under the powers vested in me by section 18(3), read together with section 20(3) and (4)) of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998), and in accordance with the formula determined by the Minister responsible for Local Government in Notice No. 967, published in Government Gazette No. 42568 dated 5 July 2019, I, Lebogang Maile, Member of the Executive Council responsible for Local Government in the Province of Gauteng, hereby determine the number of councillors for the municipal councils for the municipalities in the Province of Gauteng as set out in the Schedule hereto.

This determination shall apply to the municipal councils to be elected during the next general local government elections, the date of which is still to be proclaimed, and shall become effective on such date.
