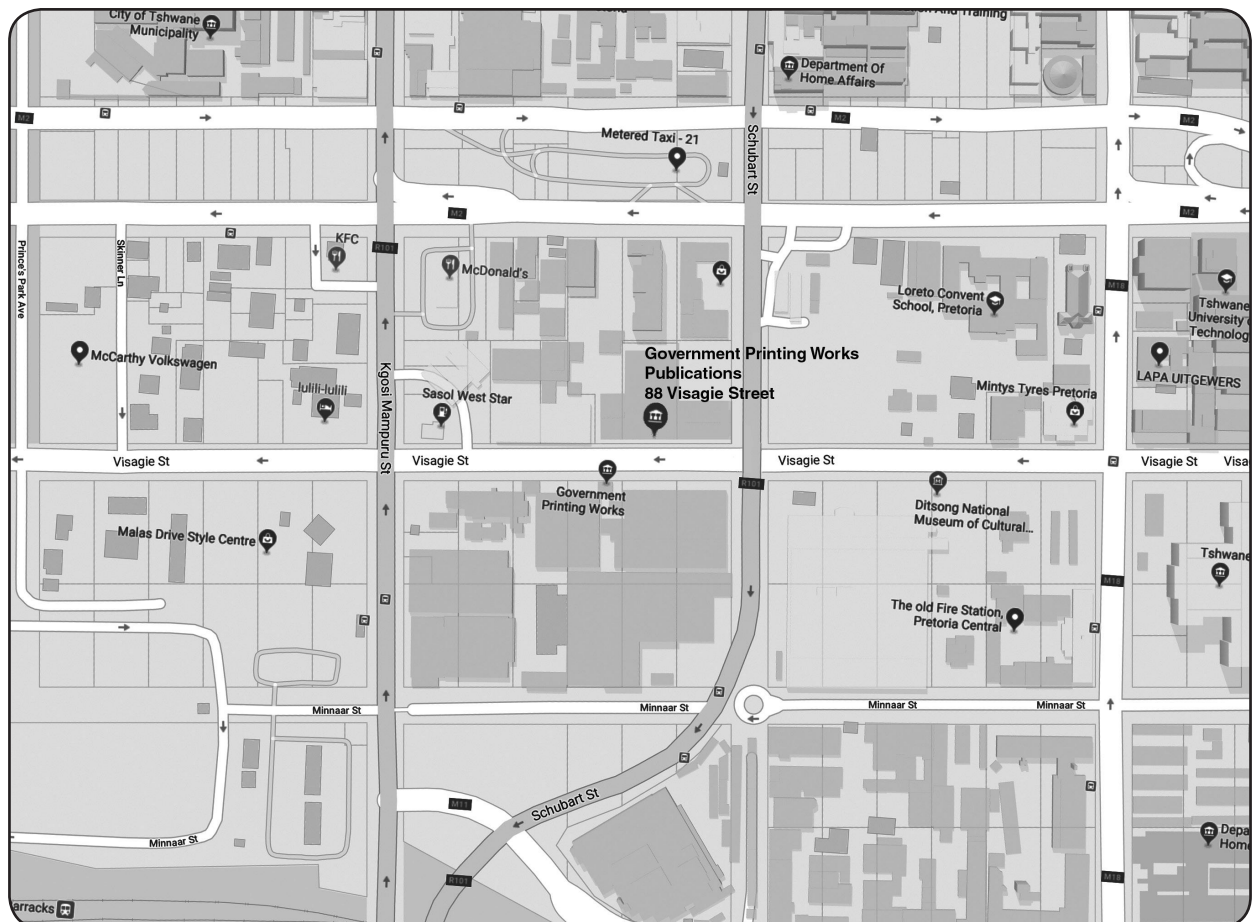

Notice is hereby given that Supaworld Gauteng (Pty) Ltd intend submitting an application to the Gauteng Gambling Board to take transfer of a bookmaker's licence from Betting World and an amendment of a bookmaker's licence, to relocate from TAB Randburg, Shop T202 & Shop T203, Oriental Plaza Stand 882, 885, 887, Ferndale, Randburg to Sam Ntuli Mall, Corner of Kumalo and Masakhane Street, Mngadi Extension 1, Katlehong.

The application will be open to public inspection at the offices of the board from 28 November 2019

Attention is directed to the provisions of Section 20 of the Gauteng Gambling Act No 4 of 1995 (as amended), which makes provision for the lodging of written representations in respect of the application.

Written representations should be lodged with the Chief Executive Officer, Gauteng Gambling Board, Private Bag 15, Bramley, 2018, within one month from 28 November 2019

Such representations shall contain at least the following information:

- (a) the name of the applicant to which representations relate;
- (b) the ground or grounds on which representations are made;
- (c) the name, address, telephone and fax number of the person submitting the representations
- (d) whether the person submitting the representations requests the board to determine that such person's identity may not be divulged and the grounds for such request; and
- (e) whether or not they wish to make oral representations at the hearing of the application.
