It is hereby notified that, whereas an error occurred in Provincial Gazette Extraordinary No. 94, Proclamation Notice No. 754 dated 23 April 2009, the local authority has approved the correction of the notice as follows:

1. Paragraph 1.8(a), (b) and (c) is hereby cancelled in its entirety and replaced by the following:

"1.8 LAND TO BE TRANSFERRED TO THE SOUTH AFRICAN NATIONAL BIODIVERSITY INSTITUTE

Erf 691 shall, prior to or simultaneously with the registration of the first erven or sectional title units in the township be transferred to the South African National Biodiversity Institute to be incorporated into the Walter Sisulu Botanical Gardens."

2. Paragraph 2.2 is hereby amended to read as follows:

"2.2 ERVEN 689 AND 690

The erven are subject to a servitude for access purposes in favour of Erf 691, which erf is to be transferred to the South African National Biodiversity Institute, as indicated by the figure PQRSTUVP on General Plan SG No. 5883/2008."
