

#### **TSHWANE AMENDMENT SCHEME 3361T**

It is hereby notified in terms of the provisions of Section 16(1)(y) of the City of Tshwane Land Use Management By-Law, 2016, that the City of Tshwane has approved and hereby adopted the land development application for the amendment of the Tshwane Amendment Scheme **3361T**, being the rezoning of Erf 24, Brooklyn, from "Residential 1", to "Special", Residential Buildings and ancillary and subservient uses such as Shops, Places of Refreshment, launderette and a hairdresser for the exclusive use of residents and visitors, with a density of 110 dwelling-units maximum, subject to certain conditions.

The Tshwane Town-planning Scheme, 2008 (Revised 2014) and the adopted scheme clauses and adopted annexure of this amendment scheme are filed with the Municipality, and are open to inspection during normal office hours.

This amendment is known as Tshwane Amendment Scheme **3361T** and shall come into operation on the date of publication of this notice.
