1. Jokerest (Pty) Ltd t/a The Joker, situated at Shop 25 Wilrogate Shopping Centre, Corner Ontdekkers Road and CR Swart Avenue, Wilrogate, Roodepoort, in the District of Johannesburg. Intends submitting an application to the Gauteng Gambling Board for Transfer of its gaming machine license to Royal Square Investments 405, Trading as The Joker as contemplated in section 35 of the Gauteng Gambling Board Act, 1995, as amended.

The applications will be open to public inspection at the offices of the board from **13<sup>th</sup> January 2020.** Attention is directed to the provisions of Section 20 of the Gauteng Gambling Act No 4 of 1995, which makes provision for the lodging of written representations in respect of the application.

- (c) the name, address, telephone and fax number of the person submitting the representations
- (d) whether the person submitting the representations requests the board to determine that such person's identity may not be divulged and the grounds for such request; and
- (e) whether or not they wish to make oral representations at the hearing of the application.
