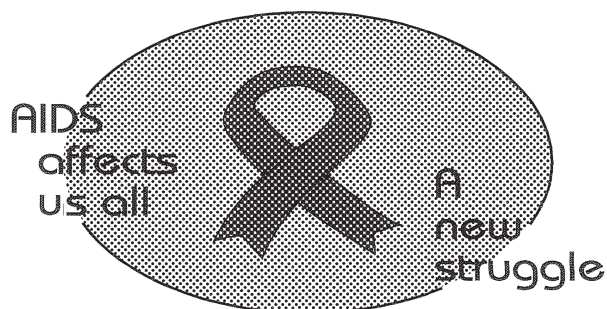

- (e) Whether or not they wish to make oral representations at the hearing of the application.
