

APPLICATION FOR A NATIONAL MANUFACTURER LICENCE

Notice is hereby given that World Sports Betting Services (Pty) Ltd of Shop D1260, Banbury Cross Village, Olievenhout Ave, Northriding intends submitting an application to the Gauteng Gambling Board for a National Manufacturer License in terms of section 38 of the National Gambling Act read with section 64 of the Gauteng Gambling Act, 1995. The application will be open to public inspection at the offices of the Board from 12 August 2020.

Attention is directed to the provisions of Section 20 of the Gauteng Gambling Act, 1995 which makes provision for the lodging of written representations in respect of the application.

Such representations should be lodged with the Chief Executive Officer, Gauteng Gambling Board, Private Bag 15, Bramley, 2018 or 125 Corlett Drive, Bramley, Johannesburg, within one month from 12 August 2020.

Such representations shall contain at least the following information:

- (a) the name of the applicant to which representations relate;
- (b) the ground or grounds on which representations are made;
- (c) the name, address, telephone and fax number of the person submitting the representations
- (d) whether the person submitting the representations requests the board to determine that such person's identity may not be divulged and the grounds for such request; and
- (e) whether or not they wish to make oral representations at the hearing of the application.
