The said transfer is exclusive and limited to the remedial work to be carried out expeditiously within reasonable timeline and cost under the authority of the Member of the Executive Council for Health, in strict compliance with the Public Finance Management Act, 1999 (Act No. 1 of 1999), to restore all or full services, following the fire incident which occurred during April 2021, at the Hospital.
