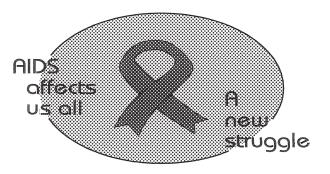

CALL FOR NOMINATIONS FOR PERSONS TO BE APPOINTED AS MEMBERS OF THE EKURHULENI MUNICIPAL PLANNING TRIBUNAL (EMPT)

CLOSING DATE: 30 MARCH 2022

In terms of the Spatial Planning and Land Use Management Act, 16 of 2013 (SPLUMA), the City of Ekurhuleni Metropolitan Municipality hereby invites nominations from members of the public to be appointed as members of the Ekurhuleni Municipal Planning Tribunal (EMPT). Appointed members will serve on this committee for a period of five (5) years, calculated from the date of appointment by the Municipality. Fields / Areas of interest may include: Town and Regional Planning, Land Use Survey, Engineering, Environmental Management, Human Settlements and Legal Services. Nominees must be persons with leadership qualities and must have knowledge and experience in spatial planning, land use management and land development, or the law related thereto, as required in terms of Section 36(1) of SPLUMA.

Each nomination shall be in writing and must contain the following information:

- (a) The name and address of the nominator, who must be a natural person and a person may nominate himself / herself;
- (b) The name, address and identity number of the nominee;
- (c) Motivation by the nominator for the appointment of the nominee to the EMPT, not exceeding one page;
- (d) A short *curriculum vitae* of the nominee, not exceeding two pages; and
- (e) Certified copies of qualifications and registration certificates, indicating registration with the relevant professional body, or voluntary association.

Failure to comply with the above requirements may result in the disqualification of the nomination. Nominees are urged to apply using the format as provided for in the SPLUMA Regulations: Land Use Management and General Matters, 2015.

Nominations can be mailed, or hand delivered to Dr Imogen Mashazi, City Manager, City of Ekurhuleni Metropolitan Municipality, O R Tambo Government Precinct, Second Floor, Head Office Building, Corner Cross and Rose Streets, Private Bag X1069, Germiston, 1400, together with the above information.
