(ACT NO. 19 OF 2007)****PROCLAMATION REGARDING TRANSFER OF POWERS AND FUNCTIONS RELATED TO CHARLOTTE MAXEKE JOHANNESBURG ACADEMIC HOSPITAL FROM MEMBER OF EXECUTIVE COUNCIL FOR INFRASTRUCTURE DEVELOPMENT TO MEMBER OF EXECUTIVE COUNCIL FOR HEALTH**

I, Malemolla David Makhura, Premier of the Gauteng Province, in terms of section 137(b) of the Constitution of the Republic of South Africa, 1996, read with sections 4(1)(c), (2)(a) and (c), 6(1)(a) and (2), 7, 8, 9, 10, 11, 12, 13(1) and (2), 14 and 18 read with sections 1, 17 and 21 of the Government Immovable Asset Management Act, 2007 (Act No. 19 of 2007), hereby transfer the custodianship of the Charlotte Maxeke Johannesburg Academic Hospital, from the Member of the Executive Council for Infrastructure Development to the Member of the Executive Council for Health. The transfer—

- (a) takes effect from 9 February 2022, which is the date of publication of a determination and proclamation regarding the original transfer in Premier's Notices 1 and 2 of 2022, respectively, in *Provincial Gazette* No. 42; and
- (b) does not affect—
- (i) the acquisition, management and disposal powers or functions entrusted to the Member of the Executive Council for Infrastructure Development in terms of Proclamation 153 of 2016 published in *Provincial Gazette* No. 376 dated 16 November 2016 in respect of immovable assets that vest in the Gauteng Provincial Government; and
- (ii) the designation of the Head of Department: Infrastructure Development as the custodian from the date of signature of a private public partnership concession agreement and for the duration thereof in respect of the Kopanong Precinct in terms of Proclamation 85 of 2019 published in *Provincial Gazette* No. 258 dated 15 August 2019; and

Premier's Notices 1 and 2 published in *Provincial Gazette* No. 42 dated 9 February 2002 are hereby withdrawn.
