- Vukani Gaming Gauteng (Pty) Ltd, Intend submitting an application to the Gauteng Gambling Board on behalf of **Kuvula Trading 25 CC** trading as **Shamrocks Irish Pub & Pub**, for a change of Route Operator for its **Type A** site licence to operate **5 (Five)** limited pay out machines at Erf 886 Cnr Grafenhem and Brits Street, Nina Park Ext 26, Wonderboom. The change of Route Operator is from Crazy Slots (Pty) Ltd to Vukani Gaming Gauteng (Pty) Ltd.

The application will be open for public inspection at the offices of the board from 22 April 2022.

Attention is directed to the provisions of Section 20 of the Gauteng Gambling Act No 4 of 1995 (as amended), which makes provision for the lodging of written representations in respect of the application.

Written representations should be lodged with the Chief Executive Officer, Gauteng Gambling Board, Private Bag 15, Bramley, 2018, within one month from 22 April 2022.

Such representations shall contain at least the following information:

- (a) the name of the applicant to which representations relate;
- (b) the ground or grounds on which representations are made;
- (c) the name, address, telephone and fax number of the person submitting the representations
- (d) whether the person submitting the representations requests the board to determine that such person's identity may not be divulged and the grounds for such request; and
- (e) whether or not they wish to make oral representations at the hearing of the application.
