(ACT NO. 20 OF 1998)****DETERMINATION OF SALARIES AND ALLOWANCES PAYABLE TO MEMBERS
OF THE EXECUTIVE COUNCIL AND THE DIFFERENT MEMBERS OF THE
GAUTENG PROVINCIAL LEGISLATURE WITH EFFECT FROM 1 APRIL 2021**

1. I, Malemolla David Makhura, Premier of the Province of Gauteng, in terms of section 6(3)(a) of the Remuneration of Public Office Bearers Act, 1998 (Act No. 20 of 1998) (the "Act"), read with Proclamation No. 67 of 2022 by the President of the Republic of South Africa, published in *Government Gazette* No. 46545 dated 14 June 2022, hereby determine that the salaries and allowances payable to the positions of public office bearers in Column 3 are, with effect from 1 April 2021, set out in Column 4 of the Schedule, subject to the provisions of sections 6(2) to (8) of the Act and the elements in paragraph 2 hereof.
2. The total remuneration packages referred to in paragraph 1 above include the following elements:
 - 2.1 A basic salary component equal to 60% of the total package, which constitutes the pensionable salary;
 - 2.2 An amount of R120 000 per annum, which is an amount to which section 8(1)(d) of the Income Tax Act, 1962 (Act No. 58 of 1962), applies. This amount is included in the basic salary component;
 - 2.3 An employer's pension benefit contribution equal to 22.5% of pensionable salary; and
 - 2.4 A flexible portion for the remaining amount of the total remuneration.
3. General Notice 749 of 2021, published in *Extraordinary Provincial Gazette* No. 216 dated 8 July 2021, is hereby repealed.
