CORRECTION NOTICE: CLOVERDENE EXTENSION 15**

Notice is hereby given in terms of Section 80 of the Town Planning and Townships Ordinance, 15 of 1986, read with Section 95 of the said ordinance in respect of Cloverdene Extension 15 Township established under Local Authority Notice 108 published in the Gauteng Provincial Gazette No 16 dated 17 February 2010, read with Correction Notice 365 as placed in the Gauteng Provincial Gazette No 85 dated 16 March 2022 that the notices should be amended / deleted as follows:

1. Condition A(4)(d) must read "Should the township owner ..... provisions of (a) and (b) .....". The small (c) must be deleted.
2. Conditions A(10)(a) & (b) refers to a Section 21 Company – this reference to a Section 21 Company must be deleted.
3. Condition 10(c) must be deleted entirely. Whereafter the conditions must be renumbered – condition 10(d) to read as condition 10(c).
4. Condition A(14) in error refers to ..... 9(a) ....., this should be amended to read 10(a).
5. Although Condition A(14) was deleted entirely in Notice 365 of 16 March 2022 it in error also referred to ..... 9(a) ..... this should also be amended to read 10(a).
