

LOCAL AUTHORITY NOTICE 1444 OF 2022

NOTICE OF REQUEST FOR PUBLIC COMMENTS ON THE DRAFT OUTDOOR ADVERTISING BYLAW OF THE CITY OF JOHANNESBURG METROPOLITAN MUNICIPALITY

Notice is hereby given in terms of section 7(1) of the Rationalization of Local Government Affairs Act, 10 of 1998, that the City of Johannesburg Metropolitan Municipality, declares its intention to review its Outdoor Advertising By-law, 2009.

In terms of section 156 of the Constitution, municipalities have the Executive Authority and the right to administer the local government matters that are listed under Part B of Schedules 4 and 5 of the Constitution. One such listed matter is "Billboards and the display of advertisements in public places". Section 156(2) of the Constitution states that a municipality may make By-laws for the effective administration of such listed local government matters.

The proposed By-law seeks to regulate amongst others the application processes and procedures for approval of Outdoor Advertising Signs, categories of signs, appropriate location and extent of signs and other related matters. The City's Outdoor Advertising By-law was promulgated in the Provincial Gazette of 18 December 2009 under Local Authority Notice No. 277. It is this By-law that the city now wishes to review, and comments are being sought on the proposed amendments.

The Public and interested and affected organisations have 60 days commenting period from the date of this advert, ending by close of business on 25 October 2022. Copies of the draft By-law will lie open for inspection during office hours (from 08h00 to 15h00) at City's Libraries, Regional Offices below and can be obtained from the City's website: www.joburg.org.za

NOTICE OF REQUEST FOR PUBLIC COMMENTS ON THE AMENDMENT OF THE ELECTRICITY BY-LAWS FOR THE CITY OF JOHANNESBURG

The Council of the City of Johannesburg hereby gives notice that it intends to amend the Electricity by-laws. The public is invited to submit written comments on the proposed amendments of the By-Laws in terms of section 7(5) of the Rationalisation of Local Government Affairs Act 1998 and Section 12 of the Local Government Municipal Systems Act no 32 of 2000. The draft Electricity By-laws are amended and reviewed in order to be consistent with legislative requirements and to ensure effective implementation.

The current City of Johannesburg Electricity By laws were promulgated in 2000. In accordance with Section 11, 3(m) of the Municipal Systems Act 32 of 2000, the municipality in executing its executive mandate of provision of electricity is required to pass the by-law pertaining to this service. Chapter 7 Section 156 subsection 2 of the Constitution, states that "a municipality may take and administer by-laws for the effective administration of the matters which it has the right to administer."

The main objective of the electricity by-laws is therefore to strengthen electricity regulations within the municipality amidst rapid changes taking place in the electricity sector.

Customers as conventionally and previously governed as consumers are now prosumers of energy, i.e., they generate own electricity and use the grid as backup. This is known as the digitization and democratization of the network. These changes therefore require some regulatory framework to enable the City to control and manage customers in accordance with best practices available locally and abroad. Although the amendments cannot be claimed to have covered all eventualities possible but have however looked at the existing trends prevailing in and out of the city. Some of the unknown factors involve the following:

The public is hereby invited to submit written comments on the draft Water Services By-law in terms of section 7(5) of the Rationalisation of Local Government Affairs Act 1998, Section 12 of the Local Government Municipal Systems Act no 32 of 2000. The draft Water Services By-law are amended and reviewed to be consistent with the legislative requirements and for effective implementation.

The overall objectives of Water Services By-law are to:

- 1. Give effect to the right contained in section 27 of the Constitution of the Republic of South Africa Act, 1996, by controlling water services within the area of jurisdiction of the Council.
- 2. Ensure that water supply and sanitation services systems are protected, as per the duties required by the National Water Services Act to regulate access to water services in an equitable way and to conserve water resources.
- 3. Outline general responsibilities, obligations and prohibitions set for the citizens of the City of Johannesburg with regard to use of Water Services; and
- 4. Provide, in conjunction with other applicable law, an affective legal and administrative framework within which the municipality can manage, regulate, prevent activities that can or do cause non-compliance to the national legislations and have potential to impact adversely on the water security, public health and well-being and the environment.

The draft Water Services By-law are aimed at strengthening the regulation of use of water services at household and industrial level, prohibition of misuse of the services, water demand management and conservation, and authorization of use of alternative water sources.

The draft Wayleave By-laws is based on the Public Roads and Miscellaneous By-law -Schedule 2 Working in the Road Reserve, which has been modernised and reviewed to be consistent with the legislative requirements and for effective implementation.

The overall objectives of Wayleave By-law are to:

- 1. Provide uninterrupted services to all its residents and to improve it capability to provide effective and developmental service delivery.
- 2. Protect all Services Infrastructure within Road Reserve boundaries.
- Prevent damage to motor vehicles, injuries to motor vehicle occupants and pedestrians, reduce the travel delays caused by Road works and prevent undue reduction of the life span and durability of Roads, footways and other services infrastructure
- 4. Ensure the applicant submits the correct information in accordance to the Wayleave Application Process and the associated tariffs when seeking permission to work in the road reserve
- 5. Ensure the Wayleave Holder complies with all provision of this By-law and any prescribed or special conditions, as the case may be, relating to that Wayleave Approval and that such provisions are complied with by all wayleave holders, be they internal or external service agencies, developers and associated contractors, when working in the road reserve.
- 6. Strengthen the regulation and enforcement when excavating and maintaining services within public road reserve thus ensuring City's Road infrastructure is respected.
