CORRECTION NOTICE: PARKHAVEN EXTENSION 9 TOWNSHIP**

Notice is hereby given in terms of Section 80 of the Town Planning and Townships Ordinance, 15 of 1986, read with Section 95 of the said ordinance that Local Authority Notice 885 published in the Extraordinary Gauteng Provincial Gazette No 193 dated 01 June 2022 is hereby corrected as follows:

By the amendment of paragraph 2 to read as follows::

**2. CONDITIONS OF TITLE**

The erven mentioned hereunder shall be subject to the conditions, imposed by the local authority in terms of the provisions of the Town Planning & Townships Ordinance, 1986 as indicated.

**2.1 ERVEN 1835 AND 1836**

2.1.1 Subject to a servitude of right of way in favour of all owners and occupiers of erven in the township, as indicated on the General Plan, to guarantee access to a public road to all the residents.

2.1.2 Subject to a right of way servitude in favour of the local authority for access to the property and for upkeep of services.

2.1.3 Subject to a servitude in favour of the Local Authority for sewerage and other municipal purposes.

**2.2 ERVEN 1804 TO 1834**

All owners and occupiers of erven are entitled to a right of way servitude over Erf 1835 and Erf 1836 for access purposes.

**2.3 ERF 1804**

The erf is subject to an electrical servitude, 6m x 3m wide, in favour of the local authority as indicated on the General Plan.

**2.4 ERF 1806**

The erf is subject to a servitude for refuse removal purposes, in favour of the local authority as indicated on the General Plan.

**2.5 ERF 1821**

The erf is subject to a servitude, 2m wide, in favour of the local authority for sewerage and other municipal purposes as indicated on the General Plan.

**2.6 CONDITIONS IN FAVOUR OF THIRD PARTIES****2.6.1 ERVEN 1804 TO 1834**

(a) The erf is subject to a servitude 2m wide in favour of Parkhaven Extension 9 10 and 13 Home Owners Association NPC, Registration Number 2019/537662/08 for sewerage and other services as indicated on the General Plan.

(b) No building or other structures shall be erected within the aforesaid servitude area and no large rooted trees shall be planted within the area of such servitude or within 2m thereof.

(c) Parkhaven Extension 9 10 and 13 Home Owners Association NPC, Registration Number 2019/537662/08 shall be entitled to deposit temporarily on the land adjoining the aforesaid servitude such material as may be excavated by it during the course of the construction, maintenance or removal of such sewerage mains and other works as it, in its discretion may deem necessary and shall further be entitled to reasonable access to the said land for the aforesaid purpose subject to any damage done during the process of the construction, maintenance or removal of such sewerage mains and other works being made good by Parkhaven Extension 9 10 and 13 Home Owners Association NPC, Registration Number 2019/537662/08.

2.6.2 ERVEN 1835 AND 1836

The erven are subject to a right of way servitude for access purposes in favour of the owners and occupiers of erven in Parkhaven Extension 10 Township and Parkhaven Extension 13 Township.

2.6.3 ERVEN 1804 TO 1834

All owners and occupiers of erven in the township are entitled to a servitude of right of way for access purposes over Erf 1874 Parkhaven Extension 10 Township and Erf 1904 Parkhaven Extension 13 Township.
