Notice is hereby given that **X-Gaming (Pty) Ltd of Coachman's Crossing Office Park, 4 Brian Street, Lyme Park, Gauteng** intends submitting an application to the Gauteng Gambling Board for consent to hold an interest as contemplated in Section 38 of the Gauteng Gambling Act, 1995, as amended, in **Route Gaming Solutions (Pty) Ltd**. The application will be open to public inspection at the offices of the Board from the **26<sup>th</sup> of January 2024**.

Attention is directed to the provisions of Section 20 of the Gauteng Gambling Act, 1995 as amended, which makes provision for written representations in respect of the application.

Such representations shall contain at least the following information:

- (c) the name, address, telephone and fax number of the person submitting the representations
- (d) whether the person submitting the representations requests the board to determine that such person's identity may not be divulged and the grounds for such request; and
- (e) whether or not they wish to make oral representations at the hearing of the application.
