ELECTORAL COMMISSION

ELECTION TIMETABLE

THE Electoral Commission hereby gives notice that it has in terms of section 11 of the Local Government: Municipal Electoral Act, 2000, compiled the election timetable set out below to apply to the municipal by-elections to be held on 27 October 2004 in respect of Ward 13 of the abaQulusi Municipality [KZ263-Vryheid], Ward 15 of the Jozini Municipality [KZ272], Ward 2 of the Richmond Municipality [KZ227] as well as Ward 4 of the Msunduzi Municipality [KZ225-Pietermaritzburg] as proclaimed by Provincial Notice numbers 1231, 1232, 1233 and 1234 of 2004 as published in the *Provincial Gazette Extraordinary* No. 6291 of the KwaZulu-Natal Province, dated Friday, 1 October 2004, respectively. A reference to "section" in this election timetable is a reference to that section in the Local Government: Municipal Electoral Act, 2000 (Act No. 27 of 2000).

**Cut-off time for act to be performed**

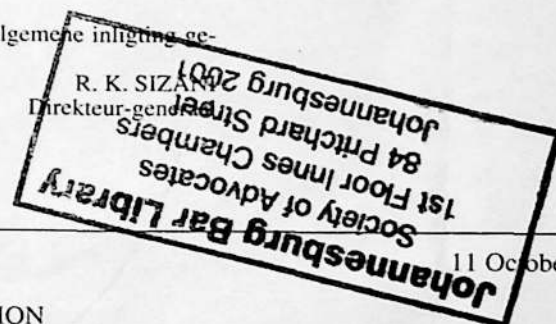
1. An act required in terms of this Act to be performed by not later than a date in the election timetable must be performed before 17:00 on that date, unless otherwise specified.

**Certification of the voters' roll**

2. By 5 October 2004 the chief electoral officer must certify the segments of the voters' roll for the voting district to be used in the by-elections in terms of section 6(2)(a).

**Notice that lists of addresses of voting stations are available for inspection**

3. By 5 October 2004 the chief electoral officer must give notice that copies of a list of voting stations and their addresses will be available for inspection at the office of the Commission's local representative in terms of section 19(5).



**Notice of route of mobile voting stations**

4. If the Commission decides to use mobile voting stations in the by-elections, the Commission must by 5 October 2004 give notice of the route, including the locations and estimated times of stopping of each mobile voting station in terms of section 22(1).

**Cut-off date for nomination of ward candidates to contest an election**

5. By not later than 19 October 2004 at 17:00, the nomination of a person to contest the by-election in a municipality as a ward candidate, must be submitted to the Commission's local representative on a prescribed form and in the prescribed manner in terms of section 17(1).

**Cut-off date for compilation and certification of ward candidate lists**

6. By 21 October 2004 the Commission must compile for each ward a list of ward candidates, certify those lists for that by-election, and keep copies of the lists available at the office of the Commission's local representative in terms of section 18(1).

**Cut-off date for issuing certificates**

7. By 22 October 2004 the Commission must issue to each ward candidate contesting the by-election, a prescribed certificate in terms of section 18(1)(d).
