REGULASIES INGEVOLGE ARTIKEL 87 VAN DIE DOBBELWET VAN KWAZULU-NATAL, 1996 (WET NO. 10 OF 1996)

**D**IE Minister het ingevolge artikel 87 van die Dobbeltwet van KwaZulu-Natal, 1996 (Wet No. 10 van 1996), die regulasies wat by Provinsiale Kennisgewing no. 274 van 23 September 1998 uitgevaardig is, gewysig soos in die bylaag hierby uiteengesit.

**BYLAAG**

3. Die volgende regulasie vervang regulasie 156:

**“Elektroniese monitorstelsel 156.** Die elektroniese monitorstelsel vir beperkte uitbetaalmasjiene bedoel in artikel 54 van die Wet is die nasionale sentrale elektroniese monitorstelsel wat deur die Nasionale Dobbelaad ingevolge artikel 27 van die Nasionale Dobbeltwet, 2004 (Wet No. 7 van 2004) ingestel en onderhou word.”

REGULATIONS IN TERMS OF SECTION 87 OF THE KWAZULU-NATAL GAMBLING ACT, 1996 (ACT NO. 10 OF 1996)

**T**HE Minister has, in terms of section 87 of the KwaZulu-Natal Gambling Act, 1996 (Act No. 10 of 1996), amended the regulations published under Provincial Notice No. 274 dated 23 September 1998 as set out in the Schedule hereto.

**SCHEDULE**

1. The following regulation is hereby substituted for regulation 156:

**“Electronic monitoring system 156.** The electronic monitoring system for limited payout machines contemplated by section 54 of the Act shall be the national central electronic monitoring system established and maintained by the National Gambling Board in terms of section 27 of the National Gambling Act, 2004 (Act No. 7 of 2004).”

2. The following regulation is hereby substituted for regulation 210:

**“Electronic monitoring system for limited payout machines 210.** The electronic monitoring system for limited payout machines in a bingo hall shall be the national central electronic monitoring system established and maintained by the National Gambling Board in terms of section 27 of the National Gambling Act, 2004 (Act No. 7 of 2004).”

## DECLARATION OF PROVINCIAL ROADS

**I**N terms of section 7 of the KwaZulu Natal Roads Act, 2001 (Act No. 4 of 2001), the Minister declares that as from the date of publication hereof —

- (a) the roads specified in Schedule A hereunder, shall in terms of section 7(2)(b)(iii) be closed and cease to be district roads which the public has the right to use; and
- (b) the roads specified in Schedule B hereunder, shall in terms of section 7(2)(b)(iii) be closed and cease to be local roads which the public has the right to use; and
- (c) the roads specified in Schedule C hereunder, shall in terms of section 7(2)(a) be main roads; and
- (d) the roads specified in Schedule D hereunder, shall in terms of section 7(2)(a) be district roads; and
- (e) the roads specified in Schedule E hereunder, shall in terms of section 7(2)(a) be local roads.

**District Road 2284: Esibanini School — Intoyethu School**

From its junction with Main Road 36-1 near the Esibanini School, proceeding in a general north-westerly direction over Reserve No.18 No.15838, passing the Luvisi and Ekucabangeni Schools, crossing the Batshe River, passing the Melokuhle, Zicole and Intoyethu Schools, terminating at its junction with District Road 1347, near the Intoyethu School.

**UMgwaqo wesiFunda u-2284: Isikole Esibanini — Isikole Intoyethu**
