DECLARATION OF THE FARM UMVOTI LOCATION NO. 17727, PORTION 3 OF MAPUMULO MISSION NO. 8311 AND PORTION 3 OF UMPAMULA MISSION RESERVE NO. 8308 MAPHUMULO MUNICIPALITY (MPHUMULO VILLAGE) AS A FORMALIZED TOWNSHIP

IN my capacity as Deputy Manager: Development Administration (Coastal Implementation Office) in the KwaZulu-Natal Department of Local Government and Traditional Affairs, under powers vested in me by section 15(1) of the Upgrading of Land Tenure Rights Act, 1991 (Act No. 112 of 1991), read with the Delegation by the Minister of Land Affairs, dated 24 November 1995 – file reference: 3/2/3, and the delegation by the Premier, dated 10 May 2001 – file reference (L) 1/7/4/2, I declare the the farm Umvoti Location No. 17727, Portion 3 of Mapumulo Mission No. 8311 and Portion 3 of Umpamula Mission Reserve No. 8308 (Mapumulo Village), as shown on Drawing No. 6041.01 prepared by Struwig Mendes Associates, dated July 2004, to be a formalized township subject to the conditions of land use listed in the Schedule.

SCHEDULE
CONDITIONS OF LAND USE FOR MAPHUMULO VILLAGE

Application of Conditions

1. (1) The conditions of land use applies to all erven within Maphumulo Village that are registered in the Deeds Office in accordance with Drawing No. 6041.01 prepared by Struwig Mendes Associates, dated July 2004.
- (2) The conditions of land use do not render unlawful any existing use or building that has been erected in accordance with approved building plans.
- (3) The conditions of land use shall lapse from the date that a town planning scheme or zoning scheme becomes applicable to Maphumulo Village in accordance with section 12 (4) of the Upgrading of Land Tenure Rights Act, 1991.

Definitions

2. In these conditions, unless the context indicates otherwise —

"Building" means any immovable structure used for any purpose, including a tank, swimming pool, mast, aerial, a wall, retaining wall and a close-boarded fence that is more than two metres in height at any point, but excluding any shelter, open fence, post, steps, pier, ornamentation, patio, deck, recreation amenities and a temporary structure erected for building operations;

"Building Line" means a line parallel to any boundary of a lot which is conterminous with a street, public right of way or road reservation;

"Coverage" means the area of the erf covered by buildings measured over the external walls as seen vertically from above and expressed as a percentage of the area of the property. A swimming pool or tennis courts shall not be regarded as part of the area of an erf for the purposes of calculating the erf's coverage;

"Date of adoption" means the date upon which these conditions and controls were first adopted by the Municipality;

"Erf" means a registered subdivision of land or a leasehold site for which a Diagram or General Plan has been approved by the Surveyor General in terms of the Land Survey Act, No. 9 of 1927, and registered in the Deeds Registry;

"Existing Building" means a building lawfully erected before the date of adoption or a building erected in accordance with plans which were approved by the Municipality prior to that date;

"Existing Use" means, in relation to any land or building, the continuous use of that building or land for purposes for which it was designed and occupied before the approval of these conditions;

"Frontage means" the length of the boundary of an erf which is common to an existing or proposed street or pedestrian way;

"Height" means the height in storeys expressed as a number, provided that where the ground floor of a building is on more than one level, such a building shall be deemed to be made up of portions whose heights will be calculated separately as though the portions were two or more separate buildings;

"Municipality" means the Maphumulo Municipality or subsequent body of equal status which shall be responsible for enforcing and carrying into effect these conditions;

"Occupant" in relation to any building, structure or land, includes any person occupying such building, structure or land or legally entitled to occupy it, or anybody having the charge or management thereof, and includes the agent of any such person who is absent from the area or whose whereabouts are unknown;

"Owner" in relation to any building or land means—

- (a) the registered owner;
- (b) the registered holder of a right of leasehold; or
- (b) any person having formal permission to occupy.

"Rear boundary" means the boundary of an erf which is furthest away from any street boundary and which does not meet any street boundary;

"Side Boundary" means a boundary of an erf which meets a street boundary or any other boundary of any other erf which is neither the street or rear boundary;

"Storey" means the space in a building between one floor level and another or between one floor level and the ceiling or roof above and shall be interpreted as follows:

- (a) A room or set of rooms at one level, including any room of which the floor is split into two or more levels, shall be considered a storey;
- (b) A pitched roof containing a habitable room and any other type or style of roofing which contains or supports any rooms, structures or features and which the Municipality considers to be habitable, shall be considered as a storey;
- (c) A storey shall not be higher than 4.5 metres. If a storey is higher than this, each 4.5 metres, or part thereof, shall be considered as a storey;
- (d) A basement wholly below the level of the adjoining ground shall not be considered as a storey.

"Use Zone" means an area of land that is subject to the conditions of land use contained in this Schedule.

Interpretation of Use of Land and Buildings

3. **"Agricultural Building"** means a building used in connection with, or which would ordinarily be incidental to, or reasonably necessary in connection with the use of the site of that building as agricultural land, and may include an ancillary dwelling;

"Agricultural Land" means the use of land for the production of food and fibre, including farming, dairying, pasturage, agriculture, horticulture, viticulture, and animal and poultry husbandry;

"Clinic" A facility providing medical, psychiatric, or surgical service for sick or injured persons, including emergency treatment, diagnostic services, and services to out-patients, employees or visitors, and may include a day-ward, and medical suites;

"Communications tower" A structure on which an antenna or dish is installed for the transmission, broadcasting or receiving of radio, television, radar or microwaves, and similar types of devices;

"Convenience Shop" means a building, or portion of a building, restricted to the sale of convenience goods such as bread and confectionery, dairy products, fresh produce, beverages, canned foods, magazines and newspapers, at the discretion of the Municipality;

"Crisis centre" means a facility providing temporary protective sanctuary for victims of crime or abuse, including emergency housing during crisis intervention for victims of rape or abuse;

"Cropping" means the use of land for producing harvestable products, planted, grown, and cultivated in the soil;

"Day Care Centre" means a facility operated for the purpose of providing care, protection and guidance to individuals during only part of a 24 hour day; This term includes creches, nursery schools, pre-schools, day care centres for individuals, and other similar uses, but excludes public and private education facilities or any facility offering care to individuals for a full 24 hour period;

"Dwelling House" means a building constructed, used, or adapted to be used, as a dwelling unit to accommodate one household and which includes not more than one kitchen, habitable rooms for the accommodation of bona fide domestic staff, outbuildings, and accessories as are ordinarily used therewith;

"Dwelling Unit" means A self-contained inter-leading group of rooms, including a kitchen, designed and used only as the accommodation for and housing of one household, and anything appurtenant, accessory and of a nature customarily incidental thereto, but does not include an ancillary unit;

"Farm Stall" means a building used for retailing of fresh farm produce produced on site, including home made items;

"Filling Station" means a building, or portion of a building, other than a parking garage, used or constructed or designed or adapted to be used for the sale of motor fuels, lubricants, motor spares and motor accessories, and may include a convenience shop, a caretaker's flat and provision for the maintenance and/or repair of motor vehicles for reward but shall not include panel beating and spray painting";

"Funeral Parlour" A building used for the purpose of funeral management, which may include a place of worship specifically set aside for funeral services, a crematorium, a shop intended primarily for the sale and display of those commodities required for cemetery purposes, and services ordinarily ancillary to funeral management, but which does not include a monumental mason;

"Government Civic Purposes" means a building or structure used by or on behalf of the Government or Municipality for the purpose of carrying out one or more government or municipal functions which may include the supply of essential protective, health, community, administrative, support or other similar services and recreational or other similar facilities;

"Grazing" means the use of land for animal grazing;

"Hawking" means the sale of goods and services from a public place, primarily streets and pavements, usually from either a fixed stall or at a fixed place;

"Home Activity" means an activity or use, in conjunction with a dwelling unit or residential building, which shall be limited to the owner or occupant of the property, who shall reside thereon, provided that the municipality approves the activity, and provided that no activity shall be allowed between the hours of 18h00 and 07h30, except with the specific approval of the municipality. Any activities carried out in terms of this clause shall be at the discretion of the municipality who shall have the right to terminate the activity if such activity is in the opinion of the municipality, adversely affecting the amenity of surrounding erven by virtue of smell, noise, dust, fumes, vibration, aesthetics, traffic generation or any other means. The dominant use of the erf shall remain residential;

"Hospital" means an institution providing primary health services and medical or surgical care to persons, primarily inpatients, suffering from illness, disease, injury and deformity and including, as an integral part of the institution, related facilities, such as laboratories, outpatient facilities, training facilities, medical offices, and staff residences, and may include for those purposes those activities normally associated therewith that are set out under sections 132 and 157 of Public Health Act of 1919 and published in Government Notice 2103 of 30 December 1966, such as the operation of an incinerator;

"Informal trading area" means an area within which any small scale economic activity is permitted, provided that each operator occupies a defined space. Provided further that, notwithstanding anything stated to the contrary in these clauses, no specific provision shall apply to such area, unless considered necessary and so specified by the Municipality;

"Institution" means a building or portion of a building used, or designed for use, as a charitable institution including the administration thereof, and a building designed for use as a hospital, home for the aged or for mentally or physically disabled people, nursing home, sanatorium, clinic, convalescence home, orphanage, crisis centre, halfway-house or other building used as a public or private institution, but does not include a restricted building;

"Noxious Industries" means any industry or trade that by reason of fumes, gases, vapours, dust, smell, noise, vibration or other causes, is deemed by the Municipality to be likely to become dangerous or harmful to the health, welfare and amenity of the general public such as, but not limited to, smelting ores and minerals, works for the production of sulphur dyes, the processing of hides and skins, or the sintering of sulphur-bearing minerals;

"Open Space" means land designed for use by the public for parks, play lots, sports and recreation facilities and any building designed primarily for use in connection with these activities;

"Office" means a building used for business, professional, medical or administrative offices but excluding a banking hall and the direct selling or storage or display of any goods or commodity whether or not the holding of a general dealers trade licence is required;

"Parking" means land, buildings, or part of a building used for the purpose of parking six or more buses or taxis, or as a public transport station and associated parking area;

"Place of Assembly" means a building or land, social halls used for social meetings, gatherings, religious purposes or indoor recreation, but does not include a place of entertainment;

"Place of Entertainment" Land or a building, or portion of a building, constructed or designed or adapted to be used as a place of entertainment, and includes an exhibition hall, theatre, cinema, amusement park, circus arena, race track or skating ring;

"Place of Instruction" means a building used as a school, college, technical institute, academy, research laboratory, library, lecture hall, art gallery, museum or for other instruction, together with any associated land or buildings, and includes a hostel but does not include a reformatory;

"Place of Worship" means a building, or portion of a building, used or constructed or designed or adapted to be used as a church, chapel, oratory, synagogue, mosque, temple, Sunday school or other place of public devotion, but does not include a funeral chapel;

"Public Office" means an office building used for any central, provincial or municipal purpose, and includes an administrative office, municipal office, town hall, government office, court house, police station, public library, public art gallery, public museum, and buildings ordinarily ancillary thereto;

"Residential building" A building, or portion of a building, other than a dwelling house, chalet, duplex flat, semi-detached house, terrace house, maisonette or hotel, used for human habitation, together with such outbuildings as are ordinarily used therewith, and includes a block of flats, boarding house, residential club or hostel;

"Restaurant" means a building, or portion of a building, designed for use, or used primarily for the preparation of food and liquid refreshments for consumption on the premises, and may include a Fast Food restaurant, which means a building, or portion of a building, designed for use, or used primarily for the preparation of food and liquid refreshments for consumption off the premises;

"Service Industry" A light industrial building catering primarily for the local customer, and includes a builder's yard and allied trades, laundry, bakery, dairy depot, dry-cleaning and similar types of uses;

"Shelter" means a unit of residential accommodation of any material whatsoever, which may not comply with the National Building Regulations, as applicable to the area of jurisdiction of the Municipality;

"Shops" A building, or a portion of a building from which, goods are sold or kept or exposed for sale to the public whether by wholesale or retail, or a building or portion of a building constructed, designed or adapted for such use, and shall include a fast-food restaurant, showroom, and a depot for the reception of goods, but does not include an industrial building, petrol service station, milk depot, warehouse, restaurant, adult entertainment or licensed hotel, and may include a Tavern;

"Sports and recreation" means sports grounds and ancillary uses such as a clubhouse, gymnasium, squash court, pavilion, change room and any similar building used in conjunction with a sport. A clubhouse may include dining facilities and taverns;

"Tavern" means a building, or portion of a building, used or constructed or designed or adapted to be used for the consumption of liquor on the premises and may include the consumption of non-alcoholic beverages and the preparation and consumption of food, but shall not include the sale of any of the aforesaid items for consumption off the premises";

"Warehouse" A building used primarily for the storage of goods, except those of an offensive or dangerous nature, and includes premises used for businesses of a wholesale nature, but does not include buildings intended for retail business;
