#### **AMENDMENT NOTICE IN TERMS OF SECTION 16 OF THE LOCAL GOVERNMENT: MUNICIPAL STRUCTURES ACT, 1998: ESTABLISHMENT OF MUNICIPALITIES**

**I**, Dr Zweli Mkhize, in my capacity as Acting member of the KwaZulu-Natal Executive Council, responsible for local government, and in terms of section 16(1)(g) read with section 17 of the Local Government: Municipal Structures Act, 1998 (Act 117 of 1998), hereby amend Provincial Notice 344 of 2000 published on 19 September 2000, as contemplated in Provincial Notice 1756 of 2005, published in Provincial Gazette 6431 of 16 September 2005, read with the correction notice contained in Provincial Notice 3253 of 2005, published in Provincial Gazette 6445 of 25 November 2005, to incorporate amendments reflected in the new municipal demarcation published under Government Notice 1257 of 2005 in Government Gazette No. 28236 of 21 November 2005, and to give effect to the provisions of the Constitutional Twelfth Amendment Act, 2005, as set out in the Schedule hereto, which amendment is to become effective on the date of the Municipal Election on 1 March 2006.

**SCHEDULE**

Provincial Notice No. 344, 2000 published on 19 September 2000 is hereby amended as follows:

1. Clause 11 of Part 1, Chapter 1-General Provisions, is hereby amended by the deletion of sub-clause (d).
2. Clause 6 of Part 2 is hereby amended as follows:  
**“COUNCILLORS**  
 6.(1) The council of the district municipality consists of [20]26 councillors as determined in Municipal Notice No. 143 dated 13 July 2000 as corrected by Municipal Notice No. 175 dated 22 August 2000[RTF annotation: ]No notice has been published to cater for the increase to 26 Councillors, and this will have to be dealt with a.s.a.p. after the election., of whom—  
 (a) [8] 10 must be proportionally elected councillors,  
 (b) 3 must be appointed by the local municipality mentioned in Part 3 of this Schedule,  
 (c) 1 must be appointed by the local municipality mentioned in Part 4 of this Schedule,  
**[(d) 1 must be appointed by the local municipality mentioned in Part 5 of this Schedule,]**  
 (e) 2 must be appointed by the local municipality mentioned in Part 6 of this Schedule,  
 (f) [4] 3 must be appointed by the local municipality mentioned in Part 7 of this Schedule,  
 (g) 1 must be a proportionally elected councillor to represent voters in the district management area mentioned in paragraph 1(2), and  
**(h) 6 must be appointed by the local municipality mentioned in Part 8 of the Schedule.”**
3. Part 5 is hereby amended by the deletion of clauses 1 to 9.
4. The following Part 8 is hereby inserted after clause 9 of Part 7.

**“PART 8****ESTABLISHMENT OF LOCAL MUNICIPALITY**

1. For that part of the district municipal area determined in the demarcation notice as KZ 5a6, a local municipality is hereby established.

**CATEGORY**

2. The local municipality is a Category B municipality as determined by the Demarcation Board in terms of section 4 of the Act.

**TYPE**

3. The type of local municipality is that of a collective executive system combined with a ward participatory system as described in the KwaZulu-Natal Determination of Types of Municipality Act, 2000.

**BOUNDARIES**

4. The boundaries of the local municipality are as determined in the demarcation notice for KZ 5a6.

**NAME**

5. The name or provisional designation of the local municipality is Umzimkulu Municipality.

**COUNCILLORS**

- 6.(1) The council of the local municipality consists of 18 proportionally elected councillors and 18 ward councillors[RTF annotation: ]No reference “as determined in Municipal Notice 143 dated 13 July 2000 as corrected by Municipal Notice No. 175 dated 22 August 2000”, as no such notice has been published in KZN for Umzimkulu.

- (2) The Local Municipality has the following full-time Councillors:

- (a) Mayor;
- (b) Speaker;
- (c) Chairperson of the Local Economic Development Committee;
- (d) Chairperson of the Community Services Committee; and
- (e) Councillor without Portfolio.

**WARDS**

7. The local municipality has 18 wards with boundaries as determined in the demarcation notice.

**SEAT OF MUNICIPALITY**

8. The seat of the new municipality will be the Umzimkhulu Municipal Offices, until otherwise determined in terms of section 29(1) of the Act.”
