3. The type of local municipality is that of a collective executive system combined with a ward participatory system as described in the KwaZulu-Natal Determination of Types of Municipality Act, 2000.

4. The boundaries of the local municipality are as determined in the demarcation notice for KZ 5a6.

NAME

5. The name or provisional designation of the local municipality is Umzimkulu Municipality.

COUNCILLORS
