ELECTORAL COMMISSION

IN terms of section 23 of the Local Government: Municipal Demarcation Act, 1998, the Electoral Commission hereby records its view that the boundary redetermination between the eThekweni Metropolitan Municipality [ETH] on the one hand and the uMdoni Local Municipality [KZN212] and the uGu District Municipality [DC21] on the other hand, referred to in Notice No. 5 published in the KwaZulu-Natal *Provincial Gazette* No. 6485 of 25 May 2006, and Notice No. 10 published in the KwaZulu-Natal *Provincial Gazette* No. 6495 of 20 July 2006, respectively, will not materially affect the representation of voters in the councils of the affected municipalities.
