Definition

1. Amendment of Rule 11

2. The following Rule is hereby substituted for Rule 11:

"The quorum of a meeting of the General Committee shall consist of twenty representatives of each of the three funds appointed or elected in accordance with Rule 2. Should a quorum of a Fund not be present at [any meeting] the determined time for the meeting of the General Committee, [such meeting] the business of the meeting shall continue for the Fund or Funds for which the required quorum is present, and the meeting of the General Committee of the Fund or Funds for which a quorum is not present, shall be adjourned for a maximum period of 90 days to a date and place determined by the Chairman in consultation with the Director[.]: Provided that—

- (a) the Chairman of the meeting of the General Committee shall decide whether any matter for decision affects all three Funds, two Funds or only one Fund;
- (b) in the event that such later date is a public holiday, the meeting shall be held on the first business day after such public holiday; and
- (c) In the event that the required quorum is not present at such adjourned meeting, the business of the meeting shall be decided by those present at the meeting.
