KwaZulu-Natal Adjustments Appropriation Act, 2007

(Act No. 8 of 2007)

Assented to on 13-12-2007

ACT

To appropriate adjusted amounts of money from the Provincial Revenue Fund for the requirements of the Province in the 2007/08 financial year ending on 31 March 2008 and to provide for subordinate matters incidental thereto.

PREAMBLE

WHEREAS section 226(2) of the Constitution of the Republic of South Africa, 1996 provides that money may be withdrawn from the Provincial Revenue Fund only in terms of an appropriation by a provincial Act;

AND WHEREAS section 26 of the Public Finance Management Act, 1999 (Act No. 1 of 1999) provides that the Provincial Legislature must appropriate money for each financial year for the requirements of the Province;

BE IT THEREFORE ENACTED by the Provincial Legislature of the Province of KwaZulu-Natal, as follows:—

Definitions

1. In this Act, unless the context indicates otherwise, any word or expression to which a meaning has been assigned in the Public Finance Management Act has the meaning assigned to it in that Act and —

“**Act**” includes the Schedule;

“**conditional grants**” means allocations to the province from the national government’s share of revenue raised nationally, provided for in section 214(1)(c) of the Constitution of the Republic of South Africa, 1996;

“**current payments**” means any payments made by a provincial department in respect of the operational requirements of that department, and includes, amongst others, payments for the compensation of employees, goods and services, interest, rental of immovable property and financial transactions relating to assets and liabilities, but exclude transfers and subsidies, payments for capital assets and payments made under section 73 of the Public Finance Management Act;

“**payments for capital assets**” means any payments made by a provincial department –

- (a) for assets that can be used continuously or repeatedly in production for more than one year, and from which future economic benefits or service potential is expected to flow directly to the provincial department making the payment; and
- (b) that must be classified as or deemed to be payments for capital assets in accordance with the “*Reference Guide to the new Economic Format*” (November 2003, Version 2) and the “*Asset Management Framework*” (April 2004, Version 3.3), issued by the National Treasury under section 76 of the Public Finance Management Act;

“Public Finance Management Act” means the Public Finance Management Act, 1999 (Act No. 1 of 1999); and

“transfers and subsidies” means any payments made by a provincial department to another organ of state or any other person in respect of which the provincial department does not receive anything of similar value directly in return, and includes the payment of conditional grants;

Appropriation of money for the requirements of the Province

2. (1) Adjusted appropriations by the Provincial Legislature of money from the Provincial Revenue Fund for the requirements of the Province in the 2007/08 financial year, to votes and main divisions within a vote, and for the specific listed purposes, are set out in the Schedule.

(2) Spending of appropriations is subject to the Public Finance Management Act and section 3 of this Act.

Appropriation listed as specifically and exclusively

3. Despite the provisions of any law, appropriations to a vote or main divisions within a vote that are listed as specifically and exclusively may only be utilised for the purpose indicated and may not be used for any other purpose, unless an Act of the Provincial Legislature amends or changes the purpose for which it was allocated.

Short title and commencement

4. This Act is called the KwaZulu-Natal Adjustments Appropriation Act, 2007.

Tot bewilliging van aangesuiwerde bedrae geld uit die Proviniale Inkomstefonds vir die behoeftes van die Provinie ten opsigte van die 2007/08 boekjaar wat op 31 Maart 2008 eindig en om voorsiening te maak vir ondergeskikte aangeleenthede wat daarmee verband hou.

AANHEF

AANGESIEN artikel 226(2) van die Grondwet van die Republiek van Suid-Afrika, 1996, bepaal dat geld uit die Proviniale Inkomstefonds onttrek kan word slegs ingevolge 'n bewilliging deur 'n provinsiale Wet;

EN AANGESIEN artikel 26 van die Wet op Openbare Finansiële Bestuur, 1999 (Wet No. 1 van 1999), bepaal dat die Proviniale Wetgewer vir elke finansiële jaar geld vir die behoeftes van die provinsie moet bewillig;

Woordomskrywing

1. In hierdie Wet, tensy dit uit die samehang anders blyk, het enige woord of uitdrukking waaraan daar in die Wet op Openbare Finansiële

Bestuur 'n betekenis geheg is, die betekenis in daardie Wet daaraan geheg,
en beteken —

“Wet” ook die Bylae;

“voorwaardelike toekennings” toewysings aan die provinsie uit die nasionale regering se deel van inkomste wat nasionaal ingesamel word, waarvoor voorsiening gemaak word in artikel 214(1)(c) van die Grondwet van die Republiek van Suid-Afrika, 1996.

Bewilliging van geld vir die behoeftes van die provinsie

2. (Act. No. 7 of 2007)**

Assented to on 13-12-2007

ACT

To approve unauthorised expenditure as a direct charge against the Provincial Revenue Fund and to provide for matters connected therewith.

BE IT ENACTED by the Provincial Legislature of the Province of KwaZulu-Natal, as follows:—

Interpretation

1. In this Act, unless the context indicates otherwise, any word or expression to which a meaning has been assigned in the Public Finance Management Act, 1999 (Act No.1 of 1999), has the meaning assigned to it in that Act.

Approval of unauthorised expenditure

2. The unauthorised expenditure referred to in the Schedule in the amount of R2,973,671,187.73 and described in the selected Resolutions of the Provincial Standing Committee on Public Accounts identified in Column 2 of the Schedule, is approved and authorised as a direct charge against the Provincial Revenue Fund.

Recovery of unauthorised expenditure

3. This Act does not detract from or limit any right or obligation to take appropriate steps to recover unauthorised expenditure from a responsible official or former official.

Short title

4. This Act is called the KwaZulu-Natal Unauthorised Expenditure Authorisation Act, 2007.

KWAZULU-NATAL TRADITIONAL LEADERSHIP AND GOVERNANCE AMENDMENT ACT, 2007

(Act. No. 9 of 2007)

Assented to on 13-12-2007

ACT

To amend the KwaZulu-Natal Traditional Leadership and Governance Act, 2005, so as to clarify the leadership of traditional sub-communities; to provide for the power of *Inkosi* to prepare a testamentary succession document identifying his or her successor; to provide for the safekeeping of testamentary succession documents; to rectify an omission in the English version of the Act; to provide for delegations; to provide for the recognition of *Amakhosi* who were recognised as such prior to the commencement of the Act; and to provide for matters connected therewith.

BE IT ENACTED by the Provincial Legislature of the Province of KwaZulu-Natal, as follows:-

Amendment of section 1 of Act 5 of 2005

1. Section 1 of the KwaZulu-Natal Traditional Leadership and Governance Act, 2005 (Act No. 5 of 2005), hereinafter referred to as the principal Act, is hereby amended by the insertion after the definition of "traditional leader" of the following definition:

KWAZULU-NATAL TRADITIONAL LEADERSHIP AND GOVERNANCE AMENDMENT ACT, 2007

Act No. 9, 2007

“traditional sub-community” means a community –

- (a) subject to the system of traditional leadership; and
- (b) observing a system of customary law,

but which is located in an area different from the area in which *Inkosi* to whom the community owes allegiance resides.”.

Insertion of section 2A in Act 5 of 2005

2. The following section is hereby inserted in the principal Act after section 2:

“Recognition of traditional sub-communities”

2A.(1) Every *Inkosi* of a traditional sub-community may, in the manner contemplated in sections 2(2), 2(3) and 2(4)(a), read with the necessary changes, apply for the recognition of such a traditional sub-community.

(2) If the Premier grants the application for the recognition of a traditional sub-community, *Inkosi* must appoint an *Induna* to represent *Inkosi* in the area or areas under the supervision of *Inkosi* and in which *Inkosi* does not reside.

(3) Section 2(5)(b), (c) and (6) apply with the necessary changes to an application referred to in subsection (1). ”.

Amendment of section 19 of Act 5 of 2005

3. Section 19 of the principal Act is hereby amended by the substitution in subsection (1) for subparagraph (iii) of paragraph (a) of the following subparagraph:

“(iii) the Premier must, subject to subsection (3) of this section and section 3, recognise a person so identified in terms of subsection (1)(a)(i) as *Inkosi*: Provided that if the reason for the vacancy is the death of the recognised *Inkosi*, *Umndeni wenkosi* must, before identifying the person to be recognised as *Inkosi*, consider the content of the testamentary succession document referred to in section 19A.”.

Insertion of section 19A in Act 5 of 2005

4. The following section is hereby inserted in the principal Act after section 19:

"Preparation of testamentary succession document by *Inkosi*"

19A.(1) Every *Inkosi* should prepare a testamentary succession document, identifying the person to succeed as *Inkosi* in terms of the format as prescribed in the regulations.

(2) The responsible Member of the Executive Council must after consultation with the House of Traditional Leaders appoint a person to act as custodian and repository of all testamentary succession documents, and may prescribe the identity, powers, functions and duties of such custodian.

(3) The custodian and repository must keep any testamentary succession document lodged with him or her in safe custody in separate sealed envelopes, until such envelopes are opened by him or her after the death of *Inkosi* concerned, or until *Inkosi* concerned requests, in writing, the return thereof in order to amend, or alter the testamentary succession document or to execute a new testamentary succession document.

(4) Any amendment or alteration to a testamentary succession document must be in writing and signed as provided for in subsection (1).".

Amendment of section 44 of Act 5 of 2005

5. Section 44 of the principal Act is hereby amended by the substitution in the English text for the introductory clause of subsection (2) of the following introductory clause to subsection (2):

"(2) The responsible Member of the Executive Council may, by notice in the *Gazette*, make regulations and issue notices in respect of -".

Substitution of section 48 of Act 5 of 2005

6. The following section is hereby substituted for section 48 of the principal Act:

"Delegations"

- 48.(1)** The Premier may, subject to the provisions of the Traditional Leadership and Governance Framework Act, 2003 (Act No. 41 of 2003), delegate to the responsible Member of the Executive Council any role, power, function or duty conferred on, or assigned to, the Premier by this Act.
- (2) The responsible Member of the Executive Council may, subject to the provisions of the Traditional Leadership and Governance Framework Act, 2003 (Act No. 41 of 2003), delegate to the Head of Department any role, power, function or duty conferred on, or assigned to, the responsible Member of the Executive Council by this Act, except the power to make regulations and issue notices.
- (3) Any role, power, function or duty delegated in terms of subsections (1) or (2) must be exercised or performed subject to such conditions as the person who made the delegation considers necessary.
- (4) Any delegation referred to in subsections (1) or (2) –
- (a) must be in writing;
 - (b) does not prohibit the person who made the delegation from exercising that power or performing that role, function or duty; and
 - (c) may at any time be withdrawn or amended in writing by the person who made the delegation. ”.

Amendment of section 52 of Act 5 of 2005

7. Section 52 of the principal Act is hereby amended by the addition after subsection (6) of the following subsection:–

“(7) *Inkosi* recognised as such in terms of applicable provincial legislation, and who was recognised as such immediately before the commencement of this Act is regarded to have been recognised as such in terms of section 19 of this Act.”.

Short title

8. This Act is called the KwaZulu Natal Traditional Leadership and Governance Amendment Act, 2007.

**MEMORANDUM ON THE OBJECTS OF THE KWAZULU-NATAL TRADITIONAL
LEADERSHIP AND GOVERNANCE AMENDMENT BILL, 2007**

INTRODUCTION

1.(1) In 2005 the Provincial Legislature of KwaZulu-Natal passed the Traditional Leadership and Governance Act, 2005 (Act No. 5 of 2005) in order to provide for the recognition of traditional communities, the establishment and recognition of traditional councils, traditional leadership positions, the recognition of traditional leaders, houses of traditional leaders and certain ancillary matters.

(2) During the implementation of the Act it became necessary to—

- (a) deal with the position of traditional sub-communities, which had not been specifically dealt with in the Act;
- (b) provide for the power of *Inkosi* to prepare a testamentary succession document identifying his or her successor, and the process of such identification;
- (c) rectify an omission in the English text of the Act;
- (d) provide for delegations; and
- (e) provide for the recognition of Amakhosi who were recognised as such prior to the commencement of the Act.

(3) The Traditional Leadership and Governance Framework Act and the Constitution were analysed during this process and the provisions are fully compliant with the relevant prescripts. This Bill addresses those issues that are considered urgent to finalise and to give full effect to the provincial government business on traditional leadership.

CLAUSE BY CLAUSE EXPLANATION OF THE BILL

2.(1) Clauses 1 and 2 have been introduced to provide for the recognition of Traditional sub-communities, where a specific traditional community is situated in different and separate areas of KwaZulu-Natal, but owes allegiance to one *Inkosi*.

(2) Clause 3 provides that *Umndeni wenkosi* must consider the testamentary document

before identifying the person to succeed the *Inkosi* upon the *Inkosi's* death.

(3) Clause 4 provides for *Inkosi* to prepare a testamentary succession document in which *Inkosi* identifies the person he or she wishes to succeed him or her as *Inkosi*, and sets out the formalities which must be compiled with for the proper execution and safekeeping of such documents.

(4) Clause 5 rectifies an omission in the English text of section 44(2) of the KwaZulu-Natal Traditional Leadership and Governance Act, 2005

(5) Clause 6 provides for the delegation of roles, powers, functions and duties by the Premier and the responsible member of the Executive Council.

(6) Clause 7 provides for the deemed recognition of *Amakhosi* who were recognised in terms of applicable provincial legislation, and who were recognised as such immediately before the commencement of the Act, to be recognised in terms of this Act.

(7) Clause 8 provides for the short title of the Act.
