

**PROVINCIAL NOTICE—PROVINSIALE KENNISGEWING—ISAZISO SESIFUNDAZWE****No. 103****13 July 2010****KWAZULU-NATAL LEGISLATURE****PUBLICATION OF ALLOCATIONS FROM POLITICAL PARTIES FUND – 2009/2010**

In terms of Section 7 of the KwaZulu-Natal Funding of Represented Political Parties Act, Act No. 7 of 2008, I, Nerusha Naidoo, Secretary of the KwaZulu-Natal Legislature hereby publish allocations made from Political Parties' Fund for the period ended 31 March 2010:

**Allocations to represented political parties for the period ended 31 March 2010**

- (a) Opening balance at the commencement of the financial year:

As at 01 April 2009 the fund had a balance of **–R0.36 cents**.

- (b) The amount and source of moneys paid into the Political Parties' Fund.

- **R25 million** was received from the equitable share on 14 April 2009;
  - National Democratic Convention (NADECO) refunded **R3,735.56** into the political parties fund on 21 July 2009, which is an amount disclosed in their financial statements for the KwaZulu-Natal Political Parties Fund as funds not expended; and
  - Finance income amounting to **R 1,690,623.20** was deposited into the fund bank account.
- (c) Names of the Parties to whom allocations were made, and the amounts of those allocations.

- (d) The amounts invested by the Political Parties' Fund in terms of section 5(3) above, and the interest earned thereon:

The Act requires that funds must be invested with the Public Investment Corporation. When Provincial Treasury contacted the corporation to open such an investment account on behalf of the Provincial Legislature for the purpose of investing such funds, the corporation refused on the basis that they only invest big sums of money. To date no investment account has been opened as the Act does not allow funds to be invested anywhere else other than the Public Investment Corporation.

Although the investment account could not be opened funds did generate finance income amounting to **R1,690,623.20** as mentioned in paragraph (b) above

- (e) The closing balance of moneys held by the Political Parties' Fund at the end of the financial year:

The balance was **R1,327,061.16** at 31 March 2010 which is made up as follows:

Ingevolge artikel 7 van die Wet op die Befondsing van Verteenwoordigende Politieke Partye van KwaZulu-Natal, Wet No 7 van 2008, publiseer ek, Nerusha Naidoo, Sekretaris van die KwaZulu-Natal Wetgewer, hiermee toekennings wat deur die Fonds vir Politieke Partye gemaak is vir die tydperk wat op 31 Maart 2010 ten einde geloop het:

#### Toekennings aan verteenwoordigende politieke partye vir die tydperk wat op 31 Maart 2010 ten einde geloop het:

(a) Aanvangsaldo aan die begin van die boekjaar:

Op 01 April 2009 het die fonds 'n saldo van **–R0.36 sent** gehad.

(b) Die bedrag en oorsprong van gelde wat in die Fonds vir Politieke Partye inbetaal is:

- **R25 miljoen** is op 14 April 2009 van die billike aandeel ontvang;
- Die Nasionale Demokratiese Konvensie (NADEKO) het op 21 Julie 2009 **R3,735.56** aan die Fonds vir Politieke Party terugbetaal, welke bedrag in hul finansiële state vir die Fonds vir Politieke Partye aangedui word as fondse wat nie bestee is nie; en
- Finansiële inkomste ten bedrae van **R 1,690,623.20** is in die fonds se bankrekening gedeponeer.

- (d) Die bedrae wat ingevolge artikel 5 (3) hierbo deur die Fonds vir Politieke Partye belê is en die rente daarop verdien:

Die Wet vereis dat fondse in die Openbare Beleggingskorporasie belê moet word. Toe die Provinciale Tesourie die korporasie gekontak het om sodanige beleggingsrekening namens die Provinciale Wetgewer te open met die oog daarop om sodanige fondse te belê, het die korporasie geweier op grond daarvan dat hulle slegs groot bedrae geld belê. Tot op hede is geen beleggingsrekening geopen nie, aangesien die Wet nie toelaat dat fondse in enige ander plek as die Openbare Beleggingskorporasie belê word nie.

Alhoewel die beleggingsrekening nie geopen kon word nie, het fondse 'n finansiële inkomste van **R1,690,623.20** opgelewer, soos vermeld in paragraaf (b) hierbo.

Ngenkathi uMnyango Womgcinimafa Wesifundazwe uthinta le nkampani ukuba ivule le-akhawunti yokutshalwa kwezimali egameni leSishayamthetho sesiFundazwe ngenhloso yokutshalwa lezo zimali, le nkampani yenqaba ngesizathu sokuthi itshala kuphela izamba ezinkulu zemali.
