

No. 144**26 November 2012****DEPARTMENT OF CO-OPERATIVE GOVERNANCE AND TRADITIONAL AFFAIRS****DEVELOPMENT FACILITATION ACT, 1995: PROPOSED ERF 15990 LADYSMITH, LADYSMITH MALL, EMNAMBITHI/LADYSMITH MUNICIPALITY**

In terms of section 33(4) of the Development Facilitation Act, 1995, (Act No. 67 of 1995), the Development Tribunal approved the development of a Special Zone XX (Ladysmith Mall) on proposed Erf 15990 Ladysmith, Registration Division GS, Ladysmith Mall, Emnambithi/Ladysmith Municipality, subject to the following conditions of establishment relating to land use management, application of laws and suspension of restrictive conditions –

- (a) the amendment of the Ladysmith Town Planning Scheme by –
 - (i) the zoning of the land development area as a Special Zone 20 (Ladysmith Mall) as per Schedule 1; and
 - (ii) the layout of the land development area in accordance with Layout Plan No. SSI Plan 07a, dated 21 July 2011 and zoning plan SSI Plan 15a, dated 21 July 2011; and
- (b) sections 10(2), 23(1), 62(1) and 75(1)(a) and (c) of the KwaZulu-Natal Planning and Development Act, 2008 (Act No. 6 of 2008), shall not apply to the land development area for the purpose of the development thereof in accordance with the conditions of township establishment;
- (c) sections 211 and 212 of the Local Authorities Ordinance, 1974 (Ordinance No. 25 of 1974), shall not apply to the land development area for the purpose of the development thereof in accordance with the conditions of township establishment;
- (d) the provisions of the National Building Regulations and Building Standards Act, 1977 (Act No. 103 of 1977) and any other law that governs the erection of buildings within the land development area are applicable to the land development area; and
- (e) the suspension of the conditions contained in Schedule 2.
