The boundary re-determinations of the municipalities referred to in the Schedule 2 will not materially affect the representation of voters in the councils of the municipalities", with the following paragraph "In terms of section 23(2) of the Local Government: Municipal Demarcation Act, 1998, the Electoral Commission hereby expresses the view that the boundary re-determinations as determined by the Municipal Demarcation Board in terms of section 21(5)(c) of the Local Government: Municipal Demarcation Act of the municipalities referred to in the Schedule 1 will affect the representation of voters in the council of the municipalities. The boundary redeterminations of the municipalities referred to in the Schedule 2 will not materially affect the representation of voters in the councils of the municipalities".
