

Notice of intention to expropriate

Issued by the eThekweni Municipality ("the Municipality") in terms of Section 9 (3) of the Housing Act (Act No. 107 of 1997) - read with section 7 (5) of the Expropriation Act (Act No. 63 of 1975)

TO: The owner(s) (within the meaning of that term as defined in Section 1 of the Act) of the properties described in the schedule hereto;

AND TO: All other persons claiming any right to or interest in the properties described in the schedule hereto, whether by virtue of registration or otherwise and particularly any lessee, buyer or builder contemplated in terms of Section 9 (1) (d) of the Act.

NOTICE OF INTENTION TO EXPROPRIATE LAND FOR HOUSING PURPOSES BY THE ETHEKWINI MUNICIPALITY IN LOWER MALUKAZI, ISIPINGO

In order to carry out the upgrade of the existing informal settlement for inclusion into the Cornubia Integrated Human Settlement, it will be necessary for the Municipality to acquire the properties reflected on the following schedule. This the Municipality deems prudent to achieve by means of expropriation in the interest of efficient administration.

Any inconvenience or anxiety that the expropriation procedure may cause is sincerely regretted and accordingly, every effort will be made to assist you with any problems or queries you may have.

However, before the Municipality proceeds any further you are:

- a) Hereby given notice of the intention of the Municipality (subject to the approval of the MEC : Public Works and Human Settlements) to expropriate the properties listed in the schedule hereto, and
- b) Invited to submit within 30 days of the date of this notice a written statement detailing any objections you may have to the proposed expropriation.

Your attention is directed to the following salient provisions of the Expropriation Act (Act No. 63 of 1975 which are applicable upon service of a Notice of Expropriation::

- c) Section 9 (5) of the Expropriation Act which provides that "Any person who wilfully furnishes false or misleading particulars in any written instrument which he by the virtue of the provisions of subsection (1) or 3 (a) [of Section 9] delivers or causes to be delivered to the Minister, shall be guilty of an offence and liable on conviction to be punished as if he had been convicted of fraud."
- d) Section 9 (6) of the Expropriation Act which provides that "Any person who without sufficient reason refuses or fails to comply with the request by the Minister in terms of subsection (3) [of Section 9] shall be guilty of an offence and liable on conviction to a fine not exceeding R2,000 or to imprisonment for a period not exceeding six months or to both such fine and imprisonment."
- e) The offer made by the Minister shall, in accordance with the provisions of Section 10 of the Expropriation Act, be regarded as having been accepted by you if an application for a

determination of the amount of compensation by a Provincial or the Local Division of a High Court having jurisdiction in the area, is not submitted within 8 (eight) months (or such longer period as may be determined) from the date of the offer of compensation-unless it has been agreed, before the expiry period that the amount of compensation should be determined by the said court.

- f) Section 19 of the Expropriation Act, which provides that any registered mortgage bonds held over an expropriated property shall be discharged as a preferential claim.
- g) Section 8 (4) of the Expropriation Act, which reads as follows : "The owner of expropriated property shall from the date of expropriation to the date upon which the State takes possession of the property, take care and maintain the property, and if the owner willfully or negligently fails to do so and as a result thereof the property depreciates in value, the Minister may recover the amount in depreciation from the owner : Provided that the Minister shall compensate the owner for costs which, in the opinion of the Minister, were necessarily incurred after the date of expropriation in respect of such maintenance or care."

Isaziso Ngenhloso Yokudliwa Ngokomthetho Komhlaba

Sikhishwa nguMasipala waseThekwini (“uMasipala”) ngaphansi kweSigaba 9(3) somthetho wezezindlu, uHousing Act ka-1997 (uMthetho No. 107 ka-1997) - sifundwa neSigaba 7(5) somthetho i-Expropriation Act (uMthetho No.63 ka-1975)

SIYA: Kubanikazi (ngokwenzazelo yaleli gama kanjengoba lichazwe eSigabeni 1 soMthetho) bale mhlaba/izakhiwo ezichazwe kule sheduli ehambisana nalesi saziso;

KANYE: Nakubo bonke abanye abantu abathi bananoma yimaphi amalungelo noma amagunya kulo mhlaba ochazwe kule saziso, ngenxa yokuba babhalisile noma ngenye indlela, futhi ikakhulukazi noma yisiphi isiqashi, umthengi noma umakhi ophathekayo kulokhu okushiwo yisiSigaba 9(1)(d) soMthetho.

ISAZISO NGENHLOSO YOKUDLIWA NGOKOMTHETHO KOMHLABA UKUZE UMASIPALA WETHEKU AKHE IZINDLU ENZANSI NEMALUKAZI, ESIPHINGO

Ukuze kukwazi ukuba kuthuthukiswe indawo okwakhiwe kuyona imijondolo njengamanje ibe yingxenywe yephrojekthi yezindlu yaseCornubia, kuzodingeka ukuba uMasipala athole lezi ziza ezibalulwe kwisheduli elandelayo. Ukuze lokhu kwenzekwe ngendlela efanele uMasipala kufanele adle ngokomthetho lo mhlaba.

Sixolisa kakhulu ngokuphazamiseka noma ngokukhathazeka okungase kuvele ngenxa yalezi zinyathelo, futhi ngenxa yalokhu sizokwenza konke okusemandleni ukukwelekelela kunoma iyiphi inkinga noma imibuzo ongase ube nayo.

Kodwa-ke ngaphambi kokuba uMasipala aqhubeke:

- a) Uyaziswa ngenhloso kaMasipala (kuncike ekuvumeni kukaNgqongqoshe Wezemisebenzi Yomphakathi Nokuhlaliswa Kwabantu waKwaZulu-Natali) yokudla ngokomthetho lezi zindawo ezisohleni olukwisheduli ehambisana nalsi saziso, nokuthi
- b) Uyamenywa ukuba uma unanoma yiziphi izikhalo ngalokhu okuhlongozwayo kulesi saziso uzibhale phansi uzilethe zingakapheli izinsuku ezingama-30 kusukela osukwini okuphume ngalo lesi saziso.

Uyacelwa ukuba uqaphele le mibandela elandelayo yomthetho i-Expropriation Act (uMthetho No. 63 ka-1975) esebenzayo uma kukhishwa isaziso sokudliwa ngokomthetho komhlaba:

- c) Ngokwesigaba 9(5) somthetho i-Expropriation Act “noma yimuphi okuthi ngamabomu abhale phansi okungelona iqiniso noma okudukisayo okuthi ngokweSigatshana (1) noma 3(a) [ngaphansi kweSigaba 9] akuhambise noma adale ukuba kuhanjiswe kuNgqongqoshe, uyotholakala enecala futhi angase anikwe isigwebo sokulahlwa yicala lokukhwabanisa.”
- d) NgokweSigaba 9(6) somthetho i-Expropriation Act othi “noma yimuphi umuntu okuthi ngaphandle kwesizathu esiqinile ahluleke noma anqabe ukuthobela isicelo sikaNgqongqoshe

esenziwe ngaphansi kweSigatshana 3 [ngaphansi kweSigaba 9], uyotholakala enecala futhi angakhokhiswa inhlawulo engeqile ku-R2000 noma avalelwe ejele isikhathi esingevile ezinyangeni eziyisithupha noma agwetshwe kokubili”.

- e) Ngokwesigaba 10 soMthetho i-Expropriation Act, lesi sinxephezelo esiphakanyiswa uNgqongqoshe singathathwa njengesamukeliwe uwenama isicelo sesinqumo ngemali yesinxephezelo okufanele sikhishwe yiNkantolo yesiFundazwe noma uphiko lwendawo lweNkantolo Ephakeme okuyiyo enegunya lokunquma ngalezi zindaba kule ndawo singafakwanga singakapheli isikhathi esiyizinyanga eziyisishiyagalombili (noma esinye isikhathi eside kunalesi esinganqunywa) kusukela osukwini okukhishwe ngalo isaziso sokuba wamukele isinxephezelo osinikwayo – ngaphandle uma kuvunyelwene, ngaphambi kosuku lokugcina olubekiwe ukuthi inani lesinxephezelo kufanele linqunywe yile Nkantolo eshiwo.
- f) ISigaba 19 sika-Expropriation Act sihlizekela ukuthi noma iyiphi ibhondi ebhalisiwe ngalesi sakhiwo esidliwayo ithathwe njengesikweleti esikhokhwa ngaphambi kwezinye.
- g) ISigaba 8 (4) sika-Expropriation Act sifundeka kanje: “Umnikazi womhlaba odliwe ngokomthetho kufanele ukuthi kusukela ngelanga lokudliwa komhlaba kuze kube usuku uHulumeni awuthatha ngalo umhlaba, awunakekele futhi awugcine esimweni esifanele, kanti futhi uma engakwenzi lokhu ngamabomu noma ngenxa yobudedengu bese kuthi ngenxa yalokho lehle inani lomhlaba noma lesakhiwo, uNgqongqoshe angabiza leyo mali inani elehle ngayo kumnikazi: Ngaphansi kombandela wokuthi uNgqongqoshe uyombuyisela umnikazi izindleko angene kuzona, ngokubona kukaNgqongqoshe, okwakudingekile ukuba angene kuzona emva kosuku lokudliwa ngokomthetho komhlaba noma kwesakhiwo ezimaqondana nokunakekelwa kwawo.”
