

**PROCLAMATION—PROKLAMASIE—ISIMEMEZOLO****No. 2****31 March 2014****PROCLAMATION***by the**Premier of the Province of KwaZulu-Natal***AMENDMENT OF TERMS OF REFERENCE OF PROCLAMATION ESTABLISHING COMMISSION OF ENQUIRY INTO THE RECRUITMENT OF ROAD TRAFFIC INSPECTORATE PERSONNEL IN KWAZULU-NATAL**

In terms of section 127(2)(e) of the Constitution of the Republic of South Africa of 1996 (Act 108 of 1996), read with section 2(1)(b) of the KwaZulu-Natal Commissions Act, 1999 (Act No. 3 of 1999), I hereby amend the Terms of Reference of the Commission of Enquiry into the Recruitment of Road Traffic Inspectorate Personnel in KwaZulu-Natal, as set out in Part A of the Schedule to Proclamation No. 1 of 2013, as published in KwaZulu-Natal *Extraordinary Provincial Gazette* Number 908 of 1 March 2013, as follows –

(a) by the substitution for item 3 of the Terms of Reference of the following item:

“**3.** The provisions of the KwaZulu-Natal Commissions Act, 1999, are applicable to the Commission: Provided that the Commission must produce and submit its final detailed report containing a summary of the evidence, its findings and recommendations no later than fifteen months after the date of this Proclamation.”; and

(b) by the substitution for item 5 of the Terms of Reference of the following item:

“**5.** The Commission must submit interim reports and recommendations to the Premier each month prior to the final report being presented to the Premier. The Commission must complete its work within a period of fourteen months from the date of this Proclamation and must submit its final report to the Premier within a period of one month after the date on which the Commission completes its work.”.

Ngokwesigaba 127(2)(e) soMthethosisekelo weRiphabhulikhi yaseNingizimu Afrika ka 1996 (uMthetho 108 ka 1996), sifundwa nesigaba 2(1)(b) soMthetho wamaKhomishana waKwaZulu-Natali, 1999 (uMthetho No. 3 ka 1999), ngalokhu ngichibiyela amaPhuzu okuzoSetshenzelwa phezu kwawo eKhomishana yoPhenyo mayelana noHlelo lokuQashwa kwamaPhoyisa oMgwaqo olwaSetshenziswa KwaZulu-Natali, njengoba kubekwe kwiNgxene A yoHlelo IweSimemezel No. 1 sika 2013, njengoba sashicilelw kwiGazethi yesiFundazwe eyiSipesheli yaKwaZulu-Natali enguNombolo 908 mhla lu-1 kuNdasa 2013, kanje –

- (a) ngokufaka lolu hlamvu olulandelayo esikhundleni sohlamvu 3 IwamaPhuzu okuzoSetshenzelwa phezu kwawo:

“3. Izinhlinzuko zoMthetho wamaKhomishana waKwaZulu-Natali, 1999, ziyaSebenza kwiKhomishana: Kuncike ekutheni iKhomishana kumele yenze futhi ilethe umbiko wokugcina ochaza kabanzi oqukethe ubufakazi obufingqiwe, ekutholile kanye nezincomo zayo zingakapheli izinyanga eziyishumi nanhanu kushicilelw lesi Simemezel.”

- (b) nangokufaka lolu hlamvu olulandelayo esikhundleni sohlamvu 5 IwamaPhuzu okuzoSetshenzelwa phezu kwawo:

“5. IKhomishana kumele ilethe imibiko yesikhashana nezincomo kuNdunankulu njalo ngenyanga ngaphambi kokuthi umbiko wokugcina wethulwe kuNdunankulu. IKhomishana kumele iphothule umsebenzi wayo ezinyangeni eziyishumi nane kushicilelw lesi Simemezel futhi kumele ilethe umbiko wayo wokugcina kuNdunankulu esikhathini esingangenyanga kusukela osukwini ephothule ngalo umsebenzi wayo.”.

Sikhishwe ngaphansi kwesandla sami eMgungundlovu ngalolu suku mhla zingama-26 kuNdasa, oNyakeni weziNkulungwane eziMbili neShumi naNe.

Ingevolge artikel 127(2)(e) van die Grondwet van die Republiek van Suid-Afrika van 1996 (Wet 108 van 1998), saamgelees met artikel 2(1)(b) van die KwaZulu-Natal Wet op Kommissies, 1999 (Wet No. 3 van 1999), wysig ek hiermee die Verwysingsterme van die Kommissie van Onderzoek na die Werwing van Padverkeersinspektoraatpersoneel in KwaZulu-Natal, soos uiteengesit in Deel A van die Bylae tot Proklamasie No. 1 van 2013, soos gepubliseer in KwaZulu-Natal *Buitengewone Proviniale Koerant* Nommer 908 van 1 Maart 2013, soos volg –

(a) deur die vervanging van item 3 van die Verwysingsterme deur die volgende item:

**“3. Die bepalings van die KwaZulu-Natal Wet op Kommissies, 1999, is van toepassing op die Kommissie: Met dien verstande dat die Kommissie sy finale breedvoerige verslag, wat 'n opsomming van die bewyssukkies, sy bevindings en aanbevelings bevat, nie later nie as vyftien maande na die datum van hierdie Proklamasie, moet oplewer en voorlê.”; en**

(b) deur die vervanging van item 5 van die Verwysingsterme deur die volgende item:

**“5. Die Kommissie moet maandeliks tussentydse verslae en aanbevelings by die Premier indien voordat die finale verslag aan die Premier voorgelê word. Die Kommissie moet sy werkzaamhede voltooi binne 'n tydperk van veertien maande vanaf die datum van hierdie Proklamasie en moet sy finale verslag aan die Premier voorlê binne 'n tydperk van een maand na die datum waarop die Kommissie sy werkzaamhede voltooi het.”.**
