CLOSING TIMES FOR THE ACCEPTANCE OF NOTICES

1. (1) The *KwaZulu-Natal Province Provincial Gazette* is published every week on Thursday, and the closing time for the acceptance of notices which have to appear in the *KwaZulu-Natal Province Provincial Gazette* on any particular Thursday, is **15:00 one weeks prior to the publication date**. Should any Thursday coincide with a public holiday, the publication date remains unchanged. However, the closing date for acceptance of advertisements moves backwards accordingly, in order to allow for 7 working days prior to the publication date.
- (2) The date for the publication of a **Extraordinary** *KwaZulu-Natal Province Provincial Gazette* is negotiable.
2. (1) Copy of notices received **after closing time** will be held over for publication in the next *KwaZulu-Natal Province Provincial Gazette*.
- (2) Amendment or changes in copy of notices cannot be undertaken unless instructions are received **before 10:00 on Fridays**.
- (3) Copy of notices for publication or amendments of original copy can not be accepted over the telephone and must be brought about by letter, by fax or by hand. The Government Printer will not be liable for any amendments done erroneously.
- (4) In the case of cancellations a refund of the cost of a notice will be considered only if the instruction to cancel has been received on or before the stipulated closing time as indicated in paragraph 2 (2).

APPROVAL OF NOTICES (This only applies to Private Companies)

3. The KwaZulu-Natal Nature Conservation Board is the successor in title to the Natal Parks Board and the Directorate: Nature Conservation. The primary functions of the Board are to direct the management of nature conservation within the Province and protected areas; to develop and promote ecotourism within the protected areas and to develop and promote conservation partnerships with people in KwaZulu-Natal.

In terms of Section 4(4) of the KwaZulu-Natal Nature Conservation Management Act 9 of 1997, I hereby invite written nominations with motivation, from members of the public, and or organisations for persons who could be considered for appointment to the KwaZulu-Natal Nature Conservation Board. Proposed persons must have an interest in nature conservation and must be drawn from categories mentioned in Section 4 of the Act, as summarised below:

- (i) Section 4(8)(a)(i) Nominated by the House of Traditional Leaders;
- (ii) Section 4(8)(a)(ii) NGO's, institutions or groups established for the advancement of nature conservation or environmental protection in the Province;
- (iii) Section 4(8)(b)(i) From Community Based Organisations in rural areas in the Province;
- (iv) Section 4(8)(b)(ii) With extensive knowledge of the Business Sector;
- (v) Section 4(8)(b)(iii) with knowledge and experience of environmental law;
- (vi) Section 4(8)(b)(iv) nominated by the Provincial Tourism Authority;
- (vii) Section 4(8)(b)(v) extensive knowledge and experience of labour matters;
- (viii) Section 4(8)(b)(vi) persons representing Organised Agriculture;
- (ix) Section 4(8)(c)(vii) persons with extensive knowledge of the protection and management of heritage resources;
- (x) Section 4(8)(c) selected by the MEC to enhance the competence of Board.

A person cannot be appointed as a Board member if such a person is a member of the National or Provincial Parliament, or an official or an employee contemplated in the Public Service Act, 1994; is an unrehabilitated insolvent; is declared to be of unsound mind by a court; or since the date on which the Constitution came into effect, has been convicted of an offence and sentenced to more than 12 months imprisonment without the option of a fine.

Persons shall be appointed for a period of three (3) years or such lesser period as I, Michael Mabuyakhulu, MEC for Economic Development, Tourism and Environmental Affairs may determine, in terms of Section 6 of the Act.

Government Printing Works has implemented rules for completing and submitting the electronic Adobe Forms when you, the customer, submits your notice request.

Please take note of these guidelines when completing your form.

GPW Business Rules

1. No hand written notices will be accepted for processing, this includes Adobe forms which have been completed by hand.
 2. Notices can only be submitted in Adobe electronic form format to the email submission address submit.egazette@gpw.gov.za. This means that any notice submissions not on an Adobe electronic form that are submitted to this mailbox will be **rejected**. National or Provincial gazette notices, where the Z95 or Z95Prov must be an Adobe form but the notice content (body) will be an attachment.
 3. Notices brought into GPW by "walk-in" customers on electronic media can only be submitted in Adobe electronic form format. This means that any notice submissions not on an Adobe electronic form that are submitted by the customer on electronic media will be **rejected**. National or Provincial gazette notices, where the Z95 or Z95Prov must be an Adobe form but the notice content (body) will be an attachment.
 4. All customers who walk in to GPW that wish to submit a notice that is not on an electronic Adobe form will be routed to the Contact Centre where the customer will be taken through the completion of the form by a GPW representative. Where a customer walks into GPW with a stack of hard copy notices delivered by a messenger on behalf of a newspaper the messenger must be referred back to the sender as the submission does not adhere to the submission rules.
 5. All notice submissions that do not comply with point 2 will be charged full price for the notice submission.
 6. The current cut-off of all Gazette's remains unchanged for all channels. (Refer to the GPW website for submission deadlines – www.gpwonline.co.za)
 7. Incorrectly completed forms and notices submitted in the wrong format will be rejected to the customer to be corrected and resubmitted. Assistance will be available through the Contact Centre should help be required when completing the forms. (012-748 6200 or email info.egazette@gpw.gov.za)
 8. All re-submissions by customers will be subject to the above cut-off times.
 9. All submissions and re-submissions that miss the cut-off will be rejected to the customer to be submitted with a new publication date.
 10. Information on forms will be taken as the primary source of the notice to be published. Any instructions that are on the email body or covering letter that contradicts the notice form content will be ignored.

You are therefore advised that effective from **Monday, 18 May 2015** should you not comply with our new rules of engagement, all notice requests will be rejected by our new system.
