

PROVINCIAL NOTICE 53 OF 2018

NOTICE IN TERMS OF SECTION 91 OF THE NATIONAL LAND TRANSPORT ACT, 2009 (ACT NO.5 OF 2009)

I, Thomas Mxolisi Kaunda, by virtue of the powers vested in me in terms of section 91 of the National Land Transport Act, No.5 of 2009 ("the Act") as the Member of the Executive Council for the Province of the KwaZulu Natal responsible for Transport and being of the opinion that extraordinary measures are necessary to normalize transport services in the area referred to in this notice, which area is affected by violence, unrest, conflict or instability, hereby amend the declaration of "Extraordinary measures" (signed on the 3rd November 2017 and published on the Provincial Gazzette, extraordinary, of 21 November 2017) in the following areas:

- a. Ladysmith and Surrounding Areas within Alfred Duma Municipality;
- b. All taxi operations of Klipriver Taxi Association;
- c. All taxi operations of Sizwe-Transport Taxi Association (Ladysmith).

Having declared extraordinary measures in the above area, and invoking the provisions of Section 91(2) (a) and/or (b) of the Act, details whereof were published by me through an appropriate medium in terms of section 91 of the Act: I hereby amend the notice to bring into effect the following:

- a. The area(s) in which the extraordinary measures were declared remain affected by unrest and instability.
- b. Public safety cannot be guaranteed by the lifting of the suspension on the operations of the taxi operators stated in the notice.
- c. No sufficient effort has been made by the parties to agree to a peaceful existence and operation of their taxis.

Consequently I intend extending the period of the suspension of the operation of taxis on the affected routes by a period of six months from the termination of the initial period of the suspension.

Any interested or affected persons may make representations as to why my decision made in terms of this notice should be reconsidered. The representations must:

- (a) be made in writing, by interested or affected person(s) or duly authorized representative(s) thereof
- (b) clearly state the bases on which such person(s) claims(s) to be interested or affected
- (c) clearly states the grounds on which my decision is sought to be reconsidered

(d) be delivered by hand within seven days from the date of publication of this notice in the gazette to:
