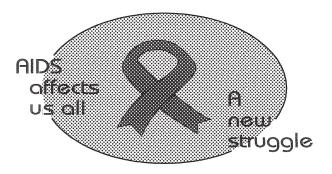

#### **PROVINCIAL NOTICE 80 OF 2018**

NOTICE IN TERMS OF SECTION 91 OF THE NATIONAL LAND TRANSPORT ACT, 2009 (ACT NO.5 OF 2009)

I, Thomas Mxolisi Kaunda, by virtue of the powers vested in me in terms of section 91 of the National Land Transport Act, No.5 of 2009 ("the Act") as the Member of the Executive Council for the Province of the KwaZulu Natal responsible for Transport and being of the opinion that extraordinary measures are necessary to normalize transport services in the area referred to in this notice, which area is affected by violence, unrest, conflict or instability, hereby declare "Extraordinary measures" in the following areas:

- a. UMbumbulu and Surrounding Areas within EThekwini Municipality;
- b. All taxi operations of Umbumbulu Taxi Association;

Having declared Extraordinary measures in the above area, I intend invoking the provisions of Section 91(2) (a) and/or (b) of the Act, further details whereof shall be published by me through an appropriate medium in terms of section 91 of the Act.

Any interested or affected persons may make representations as to why my decision made in terms of this notice should be reconsidered. The representations must:

- (a) be made in writing, by interested or affected person(s) or duly authorized representative(s) thereof
- (b) clearly state the bases on which such person(s) claims(s) to be interested or affected
- (c) clearly states the grounds on which my decision is sought to be reconsidered
- (d) be delivered by hand within seven days from the date of publication of this notice in the gazette to:
