**To amend the eThekwin Municipality: Planning and Land Use Management By law, 2016 so as to delete a subsection; and to provide for matters connected therewith.**

BE IT MADE by the eThekwin Municipal Council as follows:

**Amendment of section 18 of the eThekwin Municipality: Planning and Land Use Management By-law, 2016**

1. Section 18 of the Planning and Land Use Management By-law, 2016 is hereby amended by the deletion of subsection (4).

**Short title and commencement**

2. This By-law is called the eThekwin Municipality: Planning and Land Use Management Amendment By-law, 2019 and comes into operation on the date of publication in the *Provincial Gazette*.
